ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

The following resolution (H.R. No. 218) was announced by the Clerk and the following action taken:

H.R. No. 218, entitled: "HOUSE RESOLUTION HONORING OSWALD K. STENDER FOR A LIFETIME OF DEDICATED SERVICE TO THE NATIVE HAWAIIAN COMMUNITY," was offered by Representative Ward.

Representative Ward moved that H.R. No. 218 be adopted, seconded by Representative Tokioka.

Representative Ward honored a great Hawaiian, American and civil servant whose *raison d'être* is to improve the quality of life for the Hawaiian people, commended him on his lifetime of service, acknowledged his many achievements and awards, and thanked and introduced honoree who was seated on the Floor of the House:

Oswald "Oz" Stender, former Bishop Estate and OHA trustee.

Representative Tokioka recognized the pillar and compass of Oz at home and at work, and introduced honoree who was seated on the Floor of the House:

Lei-Ann Durant, his daughter, OHA trustee aide, and a kumu hula.

Representative Lee thanked Oz for his work on the Windward side helping to preserve the pristine valleys, promoting reengagement of the community with *lo'i*, and supporting Native Hawaiian nonprofits and organizations.

Representative Nakamura thanked Oz Stender for supporting the Mutual Housing Association of Hawaii during his leadership as a Bishop Estate trustee, looking out for people to help them get a sense of homeownership and a sense of community.

Representative Har commended Oz Stender for always being a pillar of integrity and a model of leadership, congratulated him and thanked him for all that he does for the community.

The motion was put to vote by the Chair and carried, and H.R. No. 218 was adopted, with Representatives Creagan, DeCoite, Holt and McKelvey being excused.

The following resolution (H.R. No. 219) was announced by the Clerk and the following action taken:

H.R. No. 219, entitled: "HOUSE RESOLUTION HONORING AND COMMENDING THE NORTH SHORE COMMUNITY LAND TRUST FOR THEIR CONTRIBUTIONS TO LAND CONSERVATION," was offered by Representative Matsumoto.

Representative Matsumoto moved that H.R. No. 219 be adopted, seconded by Representative Quinlan.

Representative Matsumoto recognized the North Shore Community Land Trust for their efforts to protect the lands of the North Shore of Oahu from development, thanked them for being stewards of the land, for educating the community, and for all their work on the North Shore of Oahu.

Representative Quinlan thanked the North Shore Community Land Trust for all its hard work protecting and restoring the North Shore from Kahuku to Kaena Point to its pristine, native condition, preserving the land and community, and noted the passion and advocacy of and introduced honorees who were seated on the Floor of the House:

Adam Borrello, Executive Director; and Doug Cole, former Executive Director.

Representative Matsumoto shared her appreciation of Doug Cole for always showing up to community meetings and events and making such a huge difference in the community, thanked his wife for being her water polo coach at UH, and praised the Cole family for their dedication to the community.

The motion was put to vote by the Chair and carried, and H.R. No. 219 was adopted, with Representatives Creagan, DeCoite, Holt and McKelvey being excused.

At 12:35 o'clock p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:15 o'clock p.m.

SUSPENSION OF RULES

On motion by Representative Morikawa, seconded by Representative Matsumoto and carried, the rules were suspended for the purpose of considering a certain House Bill for Final Reading by consent calendar. (Representatives Creagan, DeCoite, Holt and McKelvey were excused.)

UNFINISHED BUSINESS

Conf. Com. Rep. No. 1 and H.B. No. 2, HD 1, SD 1, CD 1:

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2, HD 1, SD 1, CD 1 pass Final Reading, seconded by Representative Morikawa.

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'm standing in support of House Bill 2, the budget bill. First of all, I wanted to just thank the members of the House and the members of the Senate. This is an unusual monumental step where we are passing the budget a month ahead of schedule. And when we were contemplating why we would be passing the budget so early, we had extensive discussion with the Chair of WAM and the Senate. And one of the things that we reflected upon on what to do this year is what happened at the end of session last year.

"At the end of session last year, we were struck with disasters on Kauai, on the day that we finished session we had disasters that occurred on the Big Island, and I think the Big Island and Kauai and East Honolulu are still suffering the effects of some of the disasters. But at the same time, we had tremendous successes in some of the bills that passed, including the large

homeless initiative, which included about \$50 million in funding, in Ohana Zone funding, potentially \$200 million for Rental Housing Trust Fund, a significant GE exemption for the middle income affordable housing. And one of the things that I think many of the members felt, including the money chairs, was that at the end of session, because we were busy with the budget, we did not give a lot of those worthy programs the attention and due diligence that they deserve.

"And so, when we took a look at, okay what are we doing, how should we have systematic changes within the legislative process that will help have more fulfilling discussion in one of these subject matters was because of the delay in budget. And a lot of times in the past, as the veteran members will know, there were years where the budget would be decked the Thursday or Friday before the decking deadline and there would be a scramble and cattle call at the end of session where 200 bills would be in suspense until the budget bill is done. And when you look at that process, it's confusing for the public, it's confusing for the Legislature, and it's not a very transparent process.

"So, we had a discussion with WAM about whether the right thing to do is finish the budget early and allow a lot of the different major items to continue in the regular process and, I have to say, what Mr. Shawn Nakama of LRB found is very interesting. Because he looked at some legislative history from 1950, and according to the records of the constitutional convention in 1950, the taxation committee had a discussion about this very subject and it said, 'the passage of the General Appropriations Bill in the early period of the legislature is desirable in order to prevent the confusion...of passing the governor's budget in the dying moments of the legislative session.'

"So, 60 years ago, or even 70 years ago, they had a vision that the way that we have been doing all along is not the right way to do it, the way we should be doing it is lay the budget to rest early and then let's deal with all the bills and all the priorities of the Legislature, because then we and the Legislature and the executive can work together on other priority items.

"So, we are very thankful to the members of the House for allowing this change. I know the change was very hard and difficult, and I have so much respect for all the chairs, because the various chairs worked really hard to vet a lot of these budget items because we had to be working in concert with the Finance Committee, the various subject matter chairs, and the Governor's Office to get this done. So, my sincere appreciation for every member of the House for allowing this to happen."

Representative Ichiyama rose to yield her time, and the Chair "so ordered."

Representative Luke continued, stating:

"Thank you very much. My appreciation to especially Senator Donovan Dela Cruz and his staff for allowing this process.

"So, with that, I wanted to just highlight some of the things that we continue to have to work on. So, one of the things that is not in this budget is some of the homeless programs. So, one of the things that I know the Chair of Human Services & Homelessness has committed to is continuing to work with the homeless coordinator to come out with an appropriation item that will continue to address the homeless needs.

"We also have the ADC audit bill and the budget of ADC, and the Chair of Agriculture will continue to work on that. The Energy Office will be worked on, HSDC, HTDC will also be worked on. We have tons of important issues and items that we need to continue to work on, but this passage of the budget should never be an excuse for the impediment and for the reason why other bills cannot pass. So, we are very thankful that we can move this out of the way so that we can continue to do the important people's business.

"The other thing that was driving the budget discussion to end early is because of what was going on on the Big Island. The Big Island, and much *mahalo* to the Big Island Representative and the Senators, and they have heard a lot of the struggles that's going on, they are continuing to feel a lot

of the pain and they are going to need a substantial amount of time and resources to redevelop and regrow from what had happened.

"We are happy to announce that as soon as this budget is done, the Senate is planning to move to agree and pass out the disaster relief bill that the House has passed on. So, hopefully that will land with the Governor's Office. What is going on in the Big Island is they are fronting a lot of the funds to continue their daily funding, but at some point in time, we understand in the next several months, they are going to be short of funds. So, this is important for us to pass as one of the first ones that we need to take care of after the budget is done. So, that was one of the other reasons why we sped up the budget.

"So, we just wanted to thank all the members for allowing this change and this change off process, and we will be continuing to work with the various chairs and various members, and we are hopeful that this will lead to a better and transparent and more efficient and productive session for the rest of the weeks. So, thank you very much, Mr. Speaker."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations. Mr. Speaker, I think the speech was very convincing by the Finance Chair. But to some of us who are not on the inside baseball version of it, it's counterintuitive, Mr. Speaker. There should be a correlation between time and understanding of the budget. So, when we say we rushed it to understand it better, that's counterintuitive, and I think it's difficult.

"The other reasons why I have reservations is because there's something in the budget which I've argued, and I've given an amendment here earlier, regarding the Department of Hawaiian Homes. It's still not up to the former budget by the Governor unless there are Christmas trees that are out there, meaning all the appropriation bills. Until we see all of that, given this base budget, how do we know what's even in the budget because we don't know appropriation bills are going to pass.

"So, Mr. Speaker, my reservations are that we are voting this probably with one eye open and one eye closed, and if we wanted to be transparent, we should probably have a little more time to see the whole picture rather than we got this base budget and then we got all the Christmas tree appropriation budgets. For those reasons, Mr. Speaker, until I see it clearly, I will have with reservations. Thank you."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cullen rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Cullen's written remarks are as follows:

"Mr. Speaker, I rise in strong support on House Bill 2, HD1, SD1, CD1, Relating to the State Budget.

"I would first like to thank the House Chair of Finance, as well as the Senate Chair of Ways and Means, for working together and leading the Legislature towards a state budget that was done expeditiously. This zero-based/performance-based approach to the state budget allowed for more opportunity for discussion, as well as transparency to specific departments within the budget. This also allowed subject matter committee chairs the opportunity to provide more insight and transparency, through the state budget, to the public as it is vetted through its own subject matter.

"As the chair of the Legislative Management Committee, we were able to dig deeper into what was requested by the executive branch and what it would be used for as well as where it would go, as we were establishing the operating budget for the Office of the Governor within House Bill 1428 and House Bill 1429, before it was added back into House Bill 2. By doing so, we provided more transparency to the public and the opportunity to participate through testimony, as well as creating an environment that is more accountable to our taxpayers. As this budget exercise continues, it will provide the consistency in the practice that will have more fiscal

responsibility and work efficiency that will make us more responsive to our taxpayers.

"For these reasons, Mr. Speaker, I stand in full support of House Bill 2, HD1, SD1, CD1, Relating to the State Budget."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kong rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support with just a brief comment. Mr. Speaker, I'd like to thank the Finance Committee and all of the chairs in helping to put this budget together because I think as we head into conference, this actually provides that transparency so that we know what other bills to move forward and what other priorities we have to make, the choices we have to make. So, in support, in strong support of this budget. Thank you, Mr. Speaker."

Representative San Buenaventura rose to speak in support of the measure, stating:

"In strong support. I would really like to thank the Finance Chair for taking into account the needs of the Big Island. We are in fact continuing to suffer and we are running out money. So, the fast pace of this budget process, we really need it. So, thank you so much. In strong support."

Representative Say rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, just with reservations, and I want to thank the Chair for clarifying the new process that we are going through in the formulation of our state biennium budget. Thank you."

Representative Luke rose to respond, stating:

"Thank you, Mr. Speaker. Just in support. Just to address the comment of the Minority Leader, the budget that we're passing today has exactly what the Governor has asked for in DHHL's budget, no more or no less. I think what he did not look at when he looked at the base budget is the provisos, so part of the amount that was allotted do DHHL, the entire amount of \$25 million was not going into DHHL, but a significant amount of that was going to pay for fringe benefits, so that would not be going to DHHL budget, and that was spelled out in the Governor's budget. So, this is fulfilling the exact intent of the Governor's budget. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2, HD 1, SD 1, CD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Final Reading by a vote of 47 ayes, with Representatives Har, Kong, Okimoto, Say, Tokioka and Ward voting aye with reservations, and with Representatives Creagan, DeCoite, Holt and McKelvey being excused.
