Thursday, March 28, 2019

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:02 o'clock p.m., with Speaker Saiki presiding.

The invocation was delivered by Rimban Shindo Nishiyama of Honpa Hongwanji Hilo Betsuin, after which the Roll was called showing all members present with the exception of Representative Lee, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Ninth Day was deferred.

Representative San Buenaventura introduced George Massengale, Habitat for Humanity; and former Senator Andy Levin, Office of the Mayor, County of Hawaii.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS
(FLOOR PRESENTATIONS)

The following resolution (H.R. No. 220) was announced by the Clerk and the following action taken:

H.R. No. 220, entitled: "HOUSE RESOLUTION RECOGNIZING AND HONORING THE ORGANIZATIONS PUUHONUA O PUNA, HAWAII VOLUNTARY ORGANIZATIONS ACTIVE IN DISASTER, HAWAII HABITAT FOR HUMANITY ASSOCIATION, HAWAII ISLAND UNITED WAY, THE SALVATION ARMY - HAWAIIAN AND PACIFIC ISLANDS, THE AMERICAN RED CROSS OF HAWAII, AND THEIR MANY VOLUNTEERS FOR THE SERVICE AND SUPPORT GIVEN TO THE BIG ISLAND COMMUNITY DURING THE 2018 KILAUEA LAVA FLOW," was offered by Representative San Buenaventura.

Representative San Buenaventura moved that H.R. No. 220 be adopted, seconded by Representative Onishi.

Representative San Buenaventura observed the 2018 Kilauea lava flow, which began on May 3, 2018 and lasted over three months, resulting in the evacuation of approximately 2,000 residents, the loss of over 700 homes, the destruction of 1,600 acres of farmland, and the complete obliteration of the village of Kapoho, recognized the many individuals and organizations who went above and beyond to help the community, and honored and introduced honorees who were seated on the Floor of the House:

Pu'uhoonua o Puna Info & Supply Hub, represented by Lauray Gouveia, volunteer, on behalf of Ikaika Marzo, founder, which was founded by and for members of the community as a place of refuge and comfort, offering food, supplies and necessities that were given freely to those in need, and later evolved into a source of trusted information, entertainment and a place of healing;

Hawaii Voluntary Organizations Active in Disaster (VOAD), represented by Suzy Bond, Vice Chairwoman, which coordinates the help that is needed before, during and after disasters, remaining to assist residents after many other organizations and nonprofits have left Puna and helping residents to make their homes habitable again by removing Pele's hair and cleaning cinder from roofs and yards; and

Hawaii Habitat for Humanity, represented by Rene Berthiaume, Board of Directors Vice President, which helped build microunits during the disaster for families to get them out of the group disaster shelter, and continues to help evacuee owner-builders recreate a home.

Representative Onishi honored the various organizations that provided support during the 2018 Kilauea lava flow for their invaluable contributions to the community, thanked them for their service, and introduced honorees who were seated on the Floor of the House:

Hawaii Island United Way, represented by Ilihia Gionson, Board of Directors Vice Chair, which provided money to purchase temporary micro-units to house families with small children and *kūpuna* who needed special accommodation, assisted displaced residents with rental and mortgage payments, and helped Project Vision provide a mobile shower trailer;

American Red Cross, Hawaii Region, represented by Coralie Matayoshi, CEO, whose dedicated team of 665 volunteers, including Representative Ryan Yamane, worked tirelessly to keep emergency shelters open around the clock, provided casework and emergency financial assistance to 690 families, offered crisis counseling and health services to over 10,800 people, and distributed thousands of emergency supplies and snacks to evacuees; and

The Salvation Army, represented by Major Eloisa Martin, Divisional Leader, which provided over 50,000 meals to evacuees, using local restaurants to help support the local business community and protect them from financial devastation, and provided hygiene kits and vouchers to their thrift stores, helping over 1,063 households from their distribution center.

The motion was put to vote by the Chair and carried, and H.R. No. 220 was adopted, with Representative Lee being excused.

No. 225, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION CONVENING A TASK FORCE TO EXAMINE AND RECOMMEND LAWS AND REGULATIONS TO UPDATE PRIVACY LAW," was adopted, with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented two reports:

(Stand. Com. Rep. No. 1899) recommending that H.R. No. 106, as amended in HD 1, be adopted; and

(Stand. Com. Rep. No. 1900) recommending that H.C.R. No. 116, as amended in HD 1, be adopted.

Representative Belatti moved that the reports of the Committee be adopted, and that H.R. No. 106, HD 1; and H.C.R. No. 116, HD 1 be adopted, seconded by Representative Morikawa.

Representative Ward rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. No. 106, HD 1, entitled: "HOUSE RESOLUTION CONVENING A GAMBLING ADVISORY GROUP TO EXAMINE AND ASSESS THE IMPACTS OF GROWING ACCESS TO ONLINE AND ILLEGAL GAMBLING IN HAWAII," was adopted, with Representative Okimoto voting aye with reservations, with Representative Ward voting no, and with Representatives Cabanilla Arakawa and Lee being excused; and

H.C.R. No. 116, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION CONVENING A GAMBLING ADVISORY GROUP TO EXAMINE AND ASSESS THE IMPACTS OF GROWING ACCESS TO ONLINE AND ILLEGAL GAMBLING IN HAWAII," was adopted, with Representative Okimoto voting aye with reservations, with Representative Ward voting no, and with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1901) recommending that S.B. No. 107, SD 1 pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 107, SD 1, entitled: "A BILL FOR AN ACT RELATING TO VOTING," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1902) recommending that S.B. No. 94, SD 1 pass Second Reading and be placed on the calendar for Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 94, SD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Morikawa.

Representative McDermott rose to speak in opposition to the measure, stating:

"1902, I stand in opposition. Just brief comments. I'm surprised that we are doing this, this body, this building, I see it didn't originate in the House, but considering that President Obama, this is his home state, he was born here, *keiki o ka 'āina*, graduate of Punahou High School. He had to endure, within 12 states, challenges to his veracity as a candidate from frivolous lawsuits and last-minute legislation that was passed that would say, you have to produce a birth certificate. He hired 11 law firms, spent almost \$1 million, and won every time because, I'm not an attorney, but it's tough, the states can't put regulations on federal requirements to run for office. And that's why he prevailed every time.

"So, I'm surprised that we would do this to another candidate after what our own beloved President Obama had to go through, not once but twice. And I think what we'll find out, Mr. Speaker, is, if this actually comes to

fruition, that the President has a lot more money than you and I, but not as much as he tells everyone, and I think that's what's going to come out of this.

"But, I think it's a waste of our time to do this. And again, particularly what our own President went through from these lawsuits from people in the south to produce a birth certificate, he challenged it on a matter of principle, obviously, he didn't think it was appropriate. I remember asking Congressman Case in the hallway one day, I said Ed, why doesn't he just give them the birth certificate, why is he fighting this? Because I would hand it over, right?"

"So, the tax returns, there's already a mountain of financial data available in the federal financial status documents that they have to require. I think much more than you would glean from a tax return. So, I think the tax return is just a naked political issue, certainly not within the spirit of what we've been, the work we've been doing together this year. And on that, I'll end, sir. Thank you."

Representative Ward rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote with a comment, please. Mr. Speaker, to add what my colleague has just noted, I want to cite what the Attorney General has said about this bill. Having the president and the vice president require to put tax returns, according to the Attorney General, is outside of what is otherwise the eligibility to become president or to be eligible to run for president is clearly stated, that no person except a natural born citizen or a citizen of the United States at the time of the adoption of the Constitution shall be eligible to the Office of President, neither shall any person be eligible to that office unless they've stayed 14 years in the nation, and *et cetera*. The point is, the AG is saying, hey, this goes above and beyond that, and this is the state telling the federal level what you can or must do to be a candidate.

"At the same time, it tells the electoral college or the electors of the State of Hawaii that they must not vote for anybody who hasn't given their tax returns. The U.S. Supreme Court has ruled on this in *Powell v McCormack* in 1969, the U.S. Supreme Court said that Congress is limited to the standing qualifications prescribed in the Constitution. The Supreme Court has said then that the states may not impose qualifications for United States Congress in addition to those set forth in the Constitution.

"So, the AG is saying, hey, you want to lawyer up on this when it looks like it's going to be challenged. And Mr. Speaker, I would say to you and our colleagues here, this could be a very costly vote. Remember when some of us on this side of the aisle spoke against if you're a pregnancy center and you are forced by law to put or advertise an abortion sign in your clinic. We just voted on this body for \$60,000 to pay what otherwise was something that was unconstitutional. Mr. Speaker, I think this is bumping up against the same waste of taxpayers' money. And also, it's a single referral, so how much discussion has really gone into this? This is rather surprising.

"And lastly, I'd say that in 48 hours, this could be the statement that Hawaii again pokes its fingers into the eyes of the Federal Government, of which \$700 million for a rail that a lot of people in this body are anticipating, because without it we're going to be in more kimchee than we already are. So, Mr. Speaker, I end with a question. How much more do we want our taxpayers to pay for votes on this floor that are unconstitutional? Thank you."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No vote and just a few brief comments. We could have done the pregnancy center better with the language that I said, not being a mandatory requirement, and that would have saved taxpayers \$67,000. I don't see going ahead with this. It's a foolish bill, it's an absolutely foolish bill. It's not going to take effect, and all it's going to do is, I think,

make us a laughing stock nationally, and I don't like to see that happen. Thank you."

Representative DeCoite rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"In opposition. I am opposed to this bill because I understand that it may be unconstitutional. States cannot add requirements to the qualifications for the office of president and vice president because they are laid out in the Constitution. We also cannot change the qualifications for our congressional delegations because they also are laid out in the Constitution. If Hawaii and other states were to change these qualifications, then we could see a range of different qualifications for these offices. I don't believe we want this to happen. *Mahalo*."

Representative Say rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote also, to be consistent with my vote in the Judiciary Committee."

Representative Tokioka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kong rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in opposition to Stand. Com. Re. No. 1902, SB 94, SD1, Relating to Elections. This measure is unconstitutional because it intends to amend the qualifications clause of article II, section 1, clause 5 of the United States Constitution and the 12th Amendment, which encompasses the qualifications of the president in the former and both the president and vice president in the latter. Individual states cannot add qualifications, as the Constitution is a uniform body of law in which every state must abide by. The addition of qualifications would essentially contradict the Constitution's purpose.

"For these reasons, Mr. Speaker, I stand in opposition on SCR 1902, SB 94, SD1."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 94, SD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Kong and Okimoto voting aye with reservations, with Representatives DeCoite, Har, Matsumoto, McDermott, Say, Thielen, Tokioka and Ward voting no, and with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1903) recommending that S.B. No. 464, SD 2 pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 464, SD 2, entitled: "A BILL FOR AN ACT RELATING TO PRIVATE PROPERTY," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1904) recommending that S.B. No. 558 pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 558, entitled: "A BILL FOR AN ACT RELATING TO NAMES,"

passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1905) recommending that S.B. No. 325, SD 1 pass Second Reading and be placed on the calendar for Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 325, SD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 325, SD 1, entitled: "A BILL FOR AN ACT RELATING TO PARENTAGE," passed Second Reading and was placed on the calendar for Third Reading, with Representative Okimoto voting aye with reservations, and with Representatives Cabanilla Arakawa and Lee being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1906) recommending that S.B. No. 92, SD 1, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 92, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO POLICE REPORTS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cabanilla Arakawa and Lee being excused.
