## Wednesday, April 3, 2019

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:06 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Dr. Kahu Kaleo Patterson, after which the Roll was called showing all members present with the exception of Representative Quinlan, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-Third Day was deferred.

### SENATE COMMUNICATIONS

The House of Representatives reconvened at 12:46 o'clock p.m.

# ORDER OF THE DAY

# SUSPENSION OF RULES

On motion by Representative Morikawa, seconded by Representative Matsumoto and carried, the rules were suspended for the purpose of considering certain Senate Bills for Third Reading by consent calendar. (Representatives Mizuno and Quinlan were excused.)

#### UNFINISHED BUSINESS

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1921) recommending that S.B. No. 1459, SD 2, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 1459, SD 2, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Say rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1459, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE STATE SURFING COMMISSION," passed Third Reading by a vote of 50 ayes, with Representatives DeCoite, Har, Say, Tokioka and Ward voting aye with reservations, and with Representative Quinlan being excused.

Representative Takumi, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1929) recommending that S.B. No. 638, SD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 638, SD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Matayoshi rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matayoshi's written remarks are as follows:

"I am concerned that the maximum sentence is being lengthened from one year to five years. Currently, prosecutors do not even take the one-year sentence, preferring the fine. If the fine is as ineffective as testimony on the bill indicates, it is curious why prosecutors do not pursue jail time, unless the situation already does not warrant it. I am in favor of raising the fine, but am hesitant about classifying this as a felony, as it can have long term and severe impacts on individuals who may make a mistake and could seriously impact a person's livelihood, especially if prosecutors already seem hesitant about pursuing any jail time at all."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered." [Note: Representative Perruso later changed her vote to a no vote.]

Representative Cabanilla Arakawa rose to speak in opposition to the measure, stating:

"In opposition, Mr. Speaker, and I just would like to make a brief comment. And I just remind my cohorts in this Chamber that every time we up punishments to felonies, we tend to forget that we are paying \$125 a day per inmate. Thank you, Mr. Speaker."

Representative Matsumoto rose to speak in opposition to the measure, stating:

"In opposition. While our caucus respects the intent of the measure and understands the reasoning and there's been a lot of violence and difficulties with those who are consuming liquor or selling liquor after 2:00 a.m. or 4:00 a.m., there's not a lot of clarity between the sale and manufacturing in this bill, as well as asset forfeiture. And we're concerned that there's no carve out for homebrewers, which is a very popular thing now, and that they will be unfairly subject to Class C felonies as well as asset forfeiture. And so, for those reasons, I vote no and would ask for more comments to be inserted into the Journal. Thank you."

Representative Matsumoto's written remarks are as follows:

"Mr. Speaker, I rise in opposition.

"While I agree with the intent of the bill, to curb violence which may be a result of after-hours unlicensed liquor sale, this bill amends the definitions of organized crime and racketeering activity to include the unlicensed sale of liquor. Again, while I applaud the intentions of this bill, I do have concerns with the language of the measure as well as the punishment for this crime.

"My concern is that there could be unintended consequences – extremely harsh penalties. A Class C felony, a punishment of five years' imprisonment and a fine up to \$10,000, as well as asset forfeiture, would deter offenders from unlicensed selling or manufacture. Does the punishment match the crime? For the very first offense, the offender is immediately subject to a Class C felony and asset forfeiture. While this punishment may deter bad actors from selling or manufacturing liquor without a license, if this bill passes, an employee who inadvertently sells liquor after her employer's liquor license expires will be guilty of a Class C felony. A graduated punishment system may be more appropriate in this type of situation.

"For these reasons, Mr. Speaker, I am in opposition to this bill. Thank you."

Representative San Buenaventura rose to speak in opposition to the measure, stating:

"In opposition. You know, when we go through this session, talking about penal reform, this creating felonies out of license violations, nonviolent crime violations, to me is the very antithesis of penal reform. And we are spending, now with inflations, \$151 per day, that is in the event we incarcerate.

"And as I had pointed out, being a criminal defense attorney, if you are charging my client with a liquor violation for a Class C felony, I and my fellow attorneys are going to demand jury trials. So that means that there are going to be delays in prosecuting murders, in prosecuting rapes, in prosecuting violent crimes, because we are clogging up our courts with violations of liquor laws.

"And yes, I understand that we need stronger racketeering laws, but let's say that. Let's say that for multiple felonies, for actual racketeering, that they become felons. But when you start bringing in homebrewers, when you bring in restaurateurs who forgot to get a liquor license because they start selling a day before their liquor license is approved and charge them with a Class C felony. It's an automatic Class C felony. Not a multiple offence Class C felony, a single offense Class C felony. Then I'm saying that we are against penal reform. We are coming out and saying that, for minor violations, we are going to stamp you down and put you away, and that is against what we should be standing up for. Thank you very much."

Representative Tokioka rose in opposition to the measure and asked that the remarks of Representative San Buenaventura be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition, as is our entire caucus. And Mr. Speaker, in addition to asking that the words of the Chair of Human Services

& Homelessness be entered into the Journal as my own, may I say a few remarks? Thank you, Mr. Speaker," and the Chair "so ordered." (By reference only.)

Representative Thielen continued, stating:

"There is some unintended consequences that could occur from this bill. And the unfortunate thing is, there's not a defective effective date in the bill. There's not even a House draft. So, I apologize for not being more on top of this issue as it went through our Judiciary Committee, that was the time really to grab ahold of this and ask some hard questions, but it's better late than never. And the difficult thing is, if we pass the bill today, it goes right up to the Governor. And I think that there could be some bad consequences from this, so I'd like to move to recommit the bill."

Representative Thielen moved to recommit S.B. No. 638, SD 1, seconded by Representative Ward.

At 12:53 o'clock p.m., the Chair declared a recess subject to the call of the Chair

The House of Representatives reconvened at 12:57 o'clock p.m.

Representative Belatti rose to speak in opposition to the motion to recommit, stating:

"Thank you, Mr. Speaker. In opposition to the motion to recommit. Mr. Speaker, in opposition. Just to correct the record, the underlying bill already exempts out homebrewing, if you look HRS 281-3. This is a bill that is a law enforcement request to reduce the unlicensed sale of liquor in our community that is doing damage to our community. So, in opposition to the motion to recommit. Thank you, Mr. Speaker."

Representative Thielen rose to speak in support of the motion to recommit, stating:

"Thank you, Mr. Speaker. In support, of course. Mr. Speaker, it would give us the opportunity to look into this more carefully and address it next year, if it's appropriate to have this measure move forward. And I again, I am sorry that I did not pick up on that. I did take criminal law, but that was many years ago. And so, I did not pick on the unintended consequences and the breadth of coverage of this bill, where we could actually create felons out of some people that should not have been charged with a crime. So, it's like taking a deep breath and saying, okay, there have been concerns raised now, it's not too late, let's do it. Because if we don't recommit it, it goes right up to the fifth floor. Thank you, Mr. Speaker."

At this time, Representative Belatti called for the previous question.

Representative Cabanilla Arakawa rose to speak in support of the motion to recommit, stating:

"In support of the recommittal, Mr. Speaker. I sense there is a lot of members in this caucus that really have trouble passing or voting for this bill, and I think that to look for it further and have a peace of mind on everybody that's voting here today is a good thing to do for the sake of this Chamber. Thank you, Mr. Speaker."

The motion was put to a vote by the Chair and upon a voice vote, failed to carry, with Representatives Holt and Quinlan being excused.

(Main Motion)

Representative Lee rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support. This measure is one that has had four committee hearings in which we have had great opportunity to both vet and debate its merits. There's a couple of things I'd like to correct for the record in statements previously made by a number of the speakers. The first is that it's \$145 per day, not \$125, to incarcerate someone here. Which is important to keep in mind, because as our committee has looked at this bill

in conjunction with a number of the other criminal pretrial reform bills and bail reform bills, we've intentionally tried to limit the scope of taxpayer dollars being spent on incarceration, and adjudicating these cases with the right level of penalties pursuant to the right level of crime.

"In this case, Mr. Speaker, what we find is that there's a number of things that, well, let me first go into correcting just a couple of the other things. To the Majority Leader's point, I did want to correct the record that, indeed, there is a homebrew exemption as we had heard in HRS 281-3, which allows for up to 100 gallons of beer or 200 gallons of wine to be homebrewed, but it can't be sold, otherwise you'd tread into Department of Health and all sorts of other business territory. That doesn't change. This bill does not touch that exemption. It's why the language does not even referenced in the bill, it's in statute

"What this bill does try to address, Mr. Speaker, is a situation which is untenable in many of our communities, both here in Oahu and in some cases in some places on the neighbor islands, in which you've got unscrupulous, shady backroom businesses being run illegally, usually in concert with drugs, alcohol, gambling, and other sorts of seedy actions. We know that these things have been around for a long, long time. We know that we've struggled as a state to battle them, because they're still prevalent today. When you walk down the street in some wrong areas, it's clearly going on. And if you ask law enforcement, who weighed in on this bill, both the prosecutors, the police departments, and the liquor commissions, they're struggling to try and deal with the situation. So much so that our city councilmembers have weighed in, others have weighed in on this at the various committee hearings along the way.

"What this bill is designed to do is take an existing penalty, a misdemeanor for operating without a liquor license, selling alcohol without any sort of oversight, which is commonplace in many of these sorts of establishments, and up it so that it's effective. So that our law enforcement, whether it's liquor commission, police department, or the prosecutors who go in and adjudicate these cases, have the tools to be able to effectively shut down these illegal operations that are blighting our communities.

"We know right now that there's any number of situations which are in the news on a regular basis where you have these other sorts of accessory illegal activities. But one of the ways that these can be more easily shut down and more quickly shut down, responding to the constituency and the neighborhood in which these operations are in, is by using this particular tool. By moving from a misdemeanor to a felony, you are creating a situation where there is a meaningful deterrent. That's what this bill is ultimately all about.

"And I would like to correct for the record also previous statements about, if you just forget license or what not, if you do read into some of the bills as well as the testimony of the liquor commission, they try to address that situation. This is a tool that the prosecutors and law enforcement need.

"If it were an overreach, and this is the part where the committee had deliberated, if it were an overreach and too much of a slap in the face for this particular level of crime, the public defender would have come out in opposition, and they did not. And it's rare that you have anything in which the public defender and the prosecuting attorneys actually don't disagree, but this is one of those rare bills, because the situation has gotten so bad in some communities. So, Mr. Speaker, for those reasons, I rise in support. Thank you."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, opposition. Mr. Speaker, if that's what all the bill is about, then it's a redundant bill, because there's already things on the books against gambling, against cock fighting, against drugs. So, are we trying to get Al Capone with tax evasion or something? We're trying to add something so the police has another tool in their tool box.

"Ironically, this is Stand. Com. 1929. I think it was the bathtub gin that was being busted open and beers were being discovered to be brewed without paying taxes. Mr. Speaker, this is not Chicago. If what the previous speaker said is true, go for what otherwise is enforcement of drug laws, go for otherwise enforcement of the gambling laws, why you got to have

another one? And he doesn't mention that there are some after hour clubs that if they sell a beer outside of their license, which usually expires at 2:00 a.m., a policeman can come and say, hey you sold a beer at 2:05 a.m., we've got you, five years, a felony, potential. I mean, really heavy stuff.

"So, until we know there's a proliferation of moonshine and other things that are going on in the community, I don't see what the logic of this would be. And Mr. Speaker, the greatest irony of all of this, this body wants to legalize marijuana, but now it wants to criminalize guys who may drink and do a little bit of beer outside of the hours or outside of the manufacturing laws. What are we trying to do? We want to recreate the blue laws of '30s and the '40s prohibition? Mr. Speaker, this is a bill that I just don't see how it belongs in this time, in this place, and in this body. For those reasons, it's a no vote. Thank you."

Representative Okimoto rose in opposition to the measure and asked that the remarks of Representatives San Buenaventura and Matsumoto be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative San Buenaventura rose to respond, stating:

"Second time, I just want to make sure that, I'm actually looking at the statute, 281-3. I mean, being an attorney, I actually read these statutes, it says basically that the only exemption is for the head of the family to allow for manufacture of 200 gallons a year for wine and 100 gallons for beer, but only for family use. So, the kind of craft brewery that we're having for community events, it's going to be in violation, and we're looking at Class C felony.

"And if you actually look at the written testimony, all the prosecutor did was say, in support. Normally they would have a list of things. Public defender does not weigh in because frankly, when you're talking about clubs, that kind of thing, they don't represent them. Okay, it's not their *kuleana*. So, all I'm saying is, these are working day-to-day people that this is going to be a dragnet in that we are going to grab them into facing Class C felonies. And I think that's an overreach, and it looks like it's a Honoluluonly problem, maybe make it only for Honolulu.

"But you know, we do have, and I hate to agree with the Minority Leader, and he and I disagree all the time, but we do have racketeering laws and we do have gambling laws and we do have all of these tools to hit organized crime. This kind of Class C felony that hits our everyday people, our everyday 'ohana, our everyday friends and families, is an overreach. And that is not why we should be here. Thank you."

Representative DeCoite rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition and I'd like to adopt the words of the Chair from Human Services & Homelessness from the first time and the second time she stood up, as well as the words of the Minority Leader as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative B. Kobayashi rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I would note that the bill says that unlicensed manufacture could involve a fine not more than \$2,000, or imprison not more than one year, or both. Separate from that is the unlicensed selling, which a person could be found guilty of a Class C felony. So, a person who makes his own homebrew or wine and gives it to, I think, someone in the family, would not suffer from a Class C felony. Thank you."

Representative Takumi rose to speak in support of the measure, stating:

"Thank you very much, Mr. Speaker. In support. I'd like the words of the Judiciary Chair to be entered into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Takumi continued, stating:

"You know, the years that I've been in office, Mr. Speaker, it's very unusual that you see a bill progress through the process, that two committees in the Senate, two committees in House, there were no opposition testimony. There were two individuals that testified in opposition, but no organizations.

"Secondly, there were no votes with reservations much less no votes in either the Senate or the House as this bill progressed. Usually there is someone or some organization out there or some individual members sitting on the floor that say, hey, I have some concerns about this. Now, that's not to say those who are standing up today were asleep at the wheel and they just realized it now. But I do believe that there are many organizations in the community that really look out and advocate for and on behalf of the rights of individuals, and if this was indeed an overreach, I think we would hear loud and clear from them. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, you know I'm fond of calling this the market place of ideas where ideas come and they are sold or bought, and we're not buying it today, because not that it's last minute, but that this is an issue of which big government, as it gets bigger and bigger every time this body meets, we have to say when enough is enough. And to criminalize some of these things I think are going above and beyond that.

"Lastly, Mr. Speaker, as much as the good defense attorney from Puna has cited me, I'd like to do a reciprocal and have her remarks entered into the Journal as my own. She was very eloquent," and the Chair "so ordered." (By reference only.)

Representative Lee rose to respond, stating:

"Thank you, Mr. Speaker. I realize that this is second time, but I'd just like to correct the record. And I do appreciate the comments from the good Representative from Puna, but the prosecuting attorney did not just click 'support,' they submitted lengthy testimony, and I just want to read one paragraph from that. And I quote, 'every day, the Department prosecutes a myriad of criminal offenses that were caused or exacerbated by the consumption of liquor. Given the many dangers associated with liquor consumption, the Department strongly believes that all liquor sales (and manufacturing) should be carefully licensed and monitored. Gone unchecked, unlicensed liquor establishments are a lightning rod for overconsumption, violence and other illegal activity, posing a serious danger to anyone present at these establishments, as well as to the general public. Raising the offense of unlicensed sale of liquor from a misdemeanor to a C felony would better reflect the seriousness of this offense, and significantly strengthen the manner in which these offenses are addressed by law enforcement and our courts.' Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 638, SD 1, entitled: "A BILL FOR AN ACT RELATING TO LIQUOR," passed Third Reading by a vote of 34 ayes to 16 noes, with Representative Matayoshi voting aye with reservations, with Representatives Cabanilla Arakawa, DeCoite, Eli, Gates, Holt, Kong, Matsumoto, McDermott, Okimoto, Perruso, San Buenaventura, Thielen, Todd, Tokioka, Ward and Wildberger voting no, and with Representative Quinlan being excused.

We are already experiencing overcrowding and loss of revenues at the airports statewide due exemptions of EV. Let's not be in the same situation with FCV."

Representative Har rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in support but with reservations on Stand. Com. Rep. No. 1967, SB 661, SD1, HD1, Relating to Fuel Cell Electric Vehicles. To be clear, as an owner of a hybrid vehicle myself, I am in support of expanding the definition of 'electric vehicles' to include fuel cell electric vehicles. Instead, the issue that I have with the measure is the benefits electric vehicle (EV) owners receive.

"Mr. Speaker, people will purchase an EV because they want to do the right thing for the environment, not because they will receive benefits such as High Occupancy Vehicle (HOV) lane access and free parking. In fairness to all users of public parking, EV users should not be completely exempt from fees.

"Mr. Speaker, according to a Hawaii News Now report from March 20, 2019, the Department of Transportation contended that EVs could be costing Hawaii millions of dollars a year in lost parking revenue; one reason being free parking at airports. Travelers have made complaints that EVs take up a lot of valuable parking space. Additionally, state officials discovered that of the 4,500 parking stalls available in three of the Honolulu Airport's parking structures, 550 (about 12%) were occupied by EVs and suspect that many of the EVs are owned by airport workers or those who work nearby. Parking abuse situations like this are unacceptable and cause an inconvenience to travelers, especially during peak travel periods, such as spring break.

"In addition, the HOV lane was created for the purpose of vehicles carrying more than one person. It was never intended for single-use occupancy vehicles simply because the vehicle is electric. As a representative from West Oahu, where traffic is an everyday occurrence, we need to ensure that the HOV is being utilized as intended – to transport vehicles with more than one person with the hope of removing other vehicles from the road.

"It is for these reasons Mr. Speaker, that I stand with reservations. Thank you."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"With reservations. I am voting with reservations on this bill because I am not convinced that these vehicles should be granted parking fee exemptions, HOV use, registration, or required parking spaces in places of public accommodation. These vehicles are expensive and not yet affordable for most people, so by granting special privileges to the people who can afford them is unfair. *Mahalo*."
