And generally speaking, strategic advantages are those things of which you excel in and you've kind of either structurally or by historical abilities have been able to take the lead in that. Obviously, we always know tourism is one of our, obviously, first and biggest, and then military spending or missile defense as in Barking Sands, astronomy, space exploration, or in this case, space tourism, international sports events, and number six which goes directly to this bill, which is Senate Bill 365, We have the potential to be the Hollywood of the Pacific.

"This bill, Mr. Speaker, however, is blank in terms of the amount of money that it's going to be put in there. I think it's \$35 million is the cap presently. I would like to see as those who are on the committee to actually double that to \$70 million. People will come to Hawaii. They love Hawaii. The ability to do the films that we have with Hawaii 5-0 and all the others, it's unlimited.

"The point is, with a strategic advantage, you have to strategically take advantage of that advantage. And, Mr. Speaker, we have an opportunity here with this bill to do so, so I urge everyone to up the numbers as much as we can to make sure that we have, that we will become the Hollywood of the Pacific. Thank you."

Twenty-four-years-old, Lexi in the prime of her youth, she left this earth and her parents devastated. The Jenkins will find comfort and solace that their loss may help save someone else's child.

"Senate Bill 824 is written narrowly, with the intention to protect the freedom of choice to ride without a helmet for anyone who has a valid motorcycle license. When our visitors come to our islands full of wonderment, excitement and distractions, many are unaware of their surroundings. They don't know our roads. Add to that unfamiliar, fast moving vehicle, operating in traffic, no wonder the numbers are so high. Between 2016 and 2018, there were 23 scooter fatalities, 22 wore no helmet. With your support, colleagues, Lexi's Law can be a lifesaving legacy to other parents who won't have to experience such tragic loss. Thank you, Mr. Speaker."

"One of those most committed to the cause, a member of the 442nd and part of the infamous rescue of the Lost Battalion in France during World War II, was Mr. Hiroshi Arisumi, who, like many of our many veterans, went on to positively impact our community by developing many affordable

homes in my community. He passed away on March 8th, and tomorrow we will celebrate his life and legacy at his memorial service. So, colleagues, in honor and celebration of all our *nisei* veterans for 'Go For Broke' Day, I humbly ask today we end our session with a moment of silence in remembrance and thanks to our Maui legend, Hiroshi Arisumi, and to all, again, *nisei* veterans. Thank you, Mr. Speaker."

At this time, the members of the House of Representatives stood for a moment of silence in honor of the late Hiroshi Arisumi and all *nisei* veterans.

Representative Ichiyama: "Thank you, Mr. Speaker. Just a quick announcement that we are still collecting Easter baskets for the Women's Caucus, and donations can be dropped off at Rep.
