H.B. No. 1561, HD 1, SD 2:

Representative Belatti moved that H.B. No. 1561, HD 1, SD 2 pass Final Reading, seconded by Representative Morikawa.

Representative Say rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"With reservations. I am voting with reservations on this bill because I am not convinced that we need to spend \$100,000 for an audit of the ADC. HB 1561 does not specify any objectives for the audit, so it leaves it up to the auditor to determine. I believe this money could be used for other pressing needs that face our state.

"The ADC budget bill also specifies what will be required in its annual report including information relating to: the number of lots ADC leased or used, by size and island; the number of lots the ADC leased or used, by island, that contains protocols and conditions supporting specialty farm products; the number of vacant parcels and unoccupied parcels in the leasing process, by island, including the parcel size, location, and date the parcel was last occupied by a tenant; and a description of any lease sales or transfers approved by ADC. I am not sure what the purpose is for requesting this information, nor the questions behind the request.

"The annual report should also provide details on how it spent the money appropriated to it by the Legislature and highlight activities of what it has done in the past year. Do we need an audit to get that kind of information? *Mahalo*."

Representative Luke rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support. This is the budget of the ADC, and I just wanted to thank the good work of the Ag Chair and the members of the House for continuing to insist on transparency and accountability. What we have today is not just the ADC budget, but it also has the performance audit and the financial audit in this bill. I just wanted to also thank the Senate and my Senate counterpart, Ways and Means Chair, for agreeing to this draft. So, thank you very much."

The motion was put to vote by the Chair and carried, and H.B. No. 1561, HD 1, SD 2, entitled: "A BILL FOR AN ACT RELATING TO AGRIBUSINESS DEVELOPMENT," passed Final Reading by a vote of 49 ayes, with Representatives DeCoite and Say voting aye with reservations, and with Representatives Holt and Saiki being excused.
