

FORTY-NINTH DAY

Friday, April 12, 2019

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:03 o'clock p.m., with Vice Speaker Nakashima presiding.

REPORTS OF STANDING COMMITTEES

Representative Aquino, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 2217) recommending that S.C.R. No. 67, SD 1 be referred to the Committee on Finance.

ANNOUNCEMENTS

Representative Ward: "Mr. Speaker, today is the 158th year since the beginning of the Civil War. I only announce that because it was between the North and the South, and now the contemporary version of where we are divided is sometimes Democrat, Republican, blue, red. The point is, and it follows, I think, Pastor Chun's prayer, that we have the courage to work through our differences and not do what they did between the North and the South 158 years ago. S.C.R. No. 180, SD 1, Supporting the Development of a Hawaiian Language Plan, Including Goals, Benchmarks, Strategies, and Outcomes, to Build Upon Accomplishments and to Accelerate the Normalization of 'Olelo Hawai'i.

Representative Nakamura: "Thank you, Mr. Speaker. Tomorrow marks the one-year anniversary of the rain bombs that severely impacted East Honolulu and the North Shore of Kauai. Fifty inches of rain fell in Waipa on the North Shore over a 24-hour period, setting a national record. The floods damaged homes, vehicles, businesses, roads, schools, farms, parks, and trails, and there were 12 rock slides in a two-mile stretch.

"Mr. Speaker, while many families and businesses have recovered, there's still a stretch of highway undergoing hillside stabilization and road rebuilding. Over 1,500 residents in Wainiha and Haena have scheduled their lives for the past year around a set convoy schedule regulating when they can enter and leave their neighborhood. We have been told that the last stretch of the road repair will be done by the end of the month, while the three one-way bridges will be done in May or early June.

"Mr. Speaker, within 10 days of this flood event, the Legislature approved funding to assist Kauai. We are most grateful that funds were used, and continue to be used, to help with the recovery and rebuilding. So, on behalf of the Kauai delegation, I would like to thank you and this body for coming to the assistance of Kauai in time of our greatest need. *Mahalo*."
