

ELEVENTH DAY

Monday, February 3, 2020

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:04 p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Representative Angus L.K. McKelvey, after which the Roll was called showing all members present with the exception of Representative Say, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Tenth Day was deferred.

INTRODUCTIONS

The following introductions were made to the members of the House:

Representative Hashimoto introduced visitors from the County of Maui: Mayor Mike Victorino; Scott Teruya, director, Department of Finance; Marc Takamori, director, Department of Transportation; Rowena Dagdag-Andaya, director, Department of Public Works; and Lauren Armstrong, executive director, Maui Metropolitan Planning Organization.

Representative Kitagawa introduced her children, Maia-Joy and Noah; and her staff, Jennifer Tobar-Honold.

Representative Tarnas introduced his cousin, Dan Damm, and his partner, Dawn Holland, who were visiting from Michigan.

ORDER OF THE DAY**REPORTS OF STANDING COMMITTEES**

Representative Takumi, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 19-20) recommending that H.B. No. 1803, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1803, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative Saiki rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, could I declare a potential conflict on SCR 19-20? My wife's title company works with notaries," and the Chair ruled, "no conflict."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1803, HD 1, entitled: "A BILL FOR AN ACT RELATING TO NOTARIAL ACTS," passed Second Reading and was referred to the Committee on Judiciary, with Representative Say being excused.

Representative Takumi, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 20-20) recommending that H.B. No. 2346, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2346, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2346, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TOBACCO PRODUCTS," passed Second Reading and was referred to the Committee on Judiciary, with Representative McDermott voting no, and with Representative Say being excused.

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 21-20) recommending that H.B. No. 1877, as amended in HD 1, pass Second Reading and be referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1877, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LAND RECORDATION," passed Second Reading and was referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary, with Representative Say being excused.

Representative Johanson, for the Committee on Labor & Public Employment, presented a report (Stand. Com. Rep. No. 22-20) recommending that H.B. No. 1698, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1698, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COLLECTIVE BARGAINING," passed Second Reading and was referred to the Committee on Finance, with Representative Say being excused.

Representative Johanson, for the Committee on Labor & Public Employment, presented a report (Stand. Com. Rep. No. 23-20) recommending that H.B. No. 2054, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2054, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative Cabanilla Arakawa rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2054, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EMPLOYMENT PRACTICES," passed Second Reading and was referred to the Committee on Judiciary, with Representative Cabanilla Arakawa voting aye with reservations, and with Representative Say being excused.

Representative Johanson, for the Committee on Labor & Public Employment, presented a report (Stand. Com. Rep. No. 24-20) recommending that H.B. No. 1904, as amended in HD 1, pass Second Reading and be referred to the Committee on Lower & Higher Education.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1904, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE UNIFORM EMPLOYEE AND STUDENT ONLINE PRIVACY PROTECTION ACT," passed Second Reading and was referred to the Committee on Lower & Higher Education, with Representative Say being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 25-20) recommending that H.B. No. 1977, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1977, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Cachola rose to speak in support of the measure, stating:

"In support. This bill relates to addressing physician shortage. We have over 2,000 doctors short here in the State of Hawaii. If we pass this bill, we have the potential of at least producing 20 or even 40 doctors every year. It's an out-of-the-box way of addressing the doctor shortage. I'll be making some more amendments to this bill later on as it moves to the other

committee, and I urge every member of the House to look positively in addressing the doctor shortage and let's vote in support of this bill. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1977, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PHYSICIAN SHORTAGE," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Say being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 26-20) recommending that H.B. No. 1608, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1608, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I have a no vote and a brief comment, please. Mr. Speaker, this bill is very well intended. Drug prices are very high, and this is intended to lower those drug prices. The only problem is, it puts the State in the drug business. This is kind of the State of Hawaii drug store bill.

"The difficulty is, is that the State has never demonstrated it is capable of running a business. I repeat, the State has never demonstrated it's capable of running a business. Plus, the suitor of this, the Department of Health, doesn't even want it. They have no interest in managing or contracting this thing, as it is so-worded.

"And I think some on the Floor here will recall that we've had a big debate on the Floor here with our former Representative Marcus Oshiro said, we should start a state bank. But sanity prevailed, Mr. Speaker. We didn't get into the business, and I don't think we should get into this business either. For those reasons, a no vote. Thank you."

Representative Tokioka rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. On the same bill, 26-20, with strong reservations."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1608, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PRESCRIPTION DRUGS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Tokioka voting aye with reservations, with Representative Ward voting no, and with Representative Say being excused.
