No. 138, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Nakamura, Saiki, and Yamashita being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 165-20) recommending that H.B. No. 2630, as amended in HD 1, pass Second Reading and be referred to the Committee on Labor & Public Employment.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2630, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE TRANSITION OF THE OAHU REGIONAL HEALTH CARE SYSTEM FROM THE HAWAII HEALTH SYSTEMS CORPORATION INTO THE DEPARTMENT OF HEALTH," passed Second Reading and was referred to the Committee on Labor & Public Employment, with Representatives Nakamura, Saiki, and Yamashita being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 166-20) recommending that H.B. No. 2451, as amended in HD 1, pass Second Reading and be referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2451, HD 1 pass Second Reading and be referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kitagawa rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Johanson rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because I believe APRNs should not be prescribing lethal drugs under this law. We have only one year's experience with the Our Care, Our Choice Act and this bill may be moving too quickly. I believe it is acceptable to reduce the current waiting period from 20 days to 15 days. As this bill moves forward, we need to ensure that the safeguards we put in place when we enacted the law remain. *Mahalo*."

Representative Eli rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matayoshi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Cachola rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2451, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary, with Representatives Aquino, Cachola, Cullen, DeCoite, Johanson, McKelvey, and Yamane voting aye with reservations, with Representatives Eli, Har, Kitagawa, Matayoshi, Matsumoto, McDermott, Okimoto, Quinlan, and Ward voting no, and with Representatives Nakamura, Saiki, and Yamashita being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 167-20) recommending that H.B. No. 2540, as amended in HD 1, pass Second Reading and be referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2540, HD 1 pass Second Reading and be referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Cabanilla Arakawa rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2540, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CIGARETTES," passed Second Reading and was referred jointly to the Committee on Consumer Protection & Commerce and the Committee on Judiciary, with Representatives Cabanilla Arakawa, D. Kobayashi, McDermott, Quinlan, and Ward voting no, and with Representatives Nakamura, Saiki, and Yamashita being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 168-20) recommending that H.B. No. 2507, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2507, HD 1 pass Second Reading and be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Cabanilla Arakawa rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Thielen rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'm rising to speak in strong support of the measure. I wanted to thank the Chair of Agriculture for the very detailed information that he has provided, I hope to all of us.

"The evidence is clear how destructive cigarettes can be to the people who are smoking, but not just them, to those that inhale the secondhand smoke. And I'm old enough to remember when there was just tobacco smoke everywhere. It just was a common thing, it was not prohibited being in any of our public buildings or any place.

"My oldest son, who has never smoked, developed throat cancer, and luckily survived it, but it was a very close call as to whether or not he would survive. And that came from the secondhand smoke.

"We've done great damage to many, many of the infants and babies and children in our society. Some of them that have survived will live with that damage throughout their lives. Some of them didn't survive.

"And as a group, we have a chance to actually do something and to recognize, I don't think there's any dispute about this, to recognize the devastating health impacts from tobacco. And by passing this bill and the previous one, we're going to stop some people from beginning to smoke. The most addictive time is from the young teenager up to probably age 25. You get past that, you're going to be okay for the most part.

"So, it's a very positive public policy. I preferred the Ag Chair's prior bill that set the age of 100 as the minimum age where you could purchase tobacco products, but that didn't make it, but it made a very good statement. This one, the age 25, will get probably 95%, 98% of the people past that stage where they would become addicted to tobacco or even choose to use it.

"So, I am in strong support, Mr. Speaker, and I think this body can be very proud to take this step. We've been first in the nation for some good things, and this would be at the top of the list. Thank you."

Representative Cabanilla Arakawa rose to respond, stating:

"Mr. Speaker, I would like to speak in opposition of this bill. One thing that we don't say in this Chamber, even though I may agree with the previous speaker, is that the tobacco tax funds a lot of worthy organizations in our state. For example, the University of Hawaii, the American Cancer Society, they all dip their hands into the tobacco tax. And the smokers and the people that buy tobacco, no one ever said thank you to them for supporting these worthy causes.

"So, I would like to thank them for paying high tax for the cigarette, because it also helps certain organizations in our town. So, there is a yin and yang in this matter. But we also need to acknowledge the contribution of those smokers who donate to these worthy causes, even though they may not like it, but we all enjoy the benefits that they give.

"With that, I'm in opposition of this bill, Mr. Speaker. I do not smoke, but I see the benefit of this for those who willingly want to spend money on cigarettes. Thank you."

Representative Todd rose to speak in opposition to the measure, stating:

"In opposition with a brief comment. About 95% of smokers have their first cigarette by age 21. So, you're looking at maybe 3% of the population that have their first cigarette between 21 and 25. So, I'm not sure how much impact that would actually have.

"Perhaps a more interesting approach would be to just give you a maximum number of years where you can smoke. So, let's cap smoking where you can't smoke over 50. And maybe that would be a little bit less politically popular, but more interesting at least and just about as effective."

Representative Matayoshi rose to speak in support of the measure, stating:

"In support with a brief comment. I just want to push back on the notion that funding worthy programs through the tobacco tax should be a laudable thing. I think that it's kind of equivalent to saying that we need to keep people sick to keep the doctors employed. I don't like that. And I've heard that theory, that idea floated a number of different times, specifically for the tobacco tax, I just really don't agree with that notion. The tobacco tax is meant to go to programs to get people to quit smoking. It's like cultivating the disease to keep them employed. That's self-defeating in my mind."

Representative Holt rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Creagan rose, stating:

"Thank you, Mr. Speaker. I had sent out a bunch of information explaining this bill to the membership, and I hope they could take a look at that and understand the reasons for this. But just briefly, the Institute of Medicine was tasked with looking at three ages to raise the minimum age of purchase of cigarettes 19, 21, and 25. They thought 21 was the most accomplishable and we—"

Representative Belatti rose to a point of order, stating:

"Mr. Speaker, point of order. May we ask if it's in support or in opposition?"

Representative Creagan continued to speak in support of the measure, stating:

"In support, sorry. I rise in support. The Institute of Medicine picked 21 as the most likely, but 25 was much better. So, we did 21, we were the first state in the nation to do 21, and I think we could be the first state in the nation to do 25.

"So, this is just extending what the Institute of Medicine recommended. A lot of their rationale was protecting the brains of teenagers and young adults, the developing brains. And it's not just the idea of when they would

start smoking, but the fact that their brains are still developing, at least for males, until at least 25.

"But the other population that is highly at risk is pregnant women and their unborn and newborn babies. And that's not been very well addressed. Nicotine is a potent neurotoxin. Vaping and cigarettes provide a dose to the babies that's very damaging to their brains. Every baby of women that smoke has brain damage. How much brain damage and what part of the brains it affects may be somewhat random depending on chance, which nerves the nicotine kills. But every baby is damaged.

"In addition, even after babies are born, they die from the fact that their mother smoked. Twenty-five percent of SIDS deaths are caused by the mother smoking during pregnancy. Even if they've stopped at late pregnancy, it's too late. So, the babies are born, they go along for a couple months, and then they die. And that's caused by cigarette smoke. So, this bill will help protect at least the early pregnancies and their babies from that horrible fate. Thank you, Mr. Speaker."

Representative Gates rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"With reservations and short comments. I don't smoke, and I don't like being around people who smoke. However, when I was listening to the testimony at the hearing, there was no evidence as to why we are changing it from 21 to 25. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2507, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Judiciary, with Representative San Buenaventura voting aye with reservations, with Representative Cabanilla Arakawa, Gates, Holt, D. Kobayashi, McDermott, Quinlan, and Todd voting no, and with Representatives Nakamura, Saiki, and Yamashita being excused.
