SIXTEENTH DAY

Monday, February 10, 2020

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:03 p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by former Governor Neil Abercrombie, after which the Roll was called showing all members present with the exception of Representative Gates, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fifteenth Day was deferred.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

Representative Okimoto moved that H.R. No. 22 be adopted, seconded by Representative Holt.

Representative Holt recognized this week as Hawaiian Caucus Week 2020, E Ala e Lāhui, A Lāhui Rising, with the vision of ensuring the Legislature is engaged, informed, and educated on issues that affect our Native Hawaiian community, recognized February as 'Ōlelo Hawai'i month, and invited members to participate in the different celebrations and events throughout the week and share our Native Hawaiian language and culture.

Representative Okimoto shared how *E Ala e Lāhui* starts with our *keiki*, our 'ōpio, thanked the Kalihi-Palama Culture & Arts Society for perpetuating the Hawaiian culture by providing education, training, and services to the underprivileged population of the Kalihi-Palama area and on a statewide basis, recognized their Queen Lili'uokalani Keiki Hula Competition and Malia Craver Hula Kahiko Competition for highlighting our 'ōpio in the art of Hawaiian dance, and introduced honorees from the Kalihi-Palama Culture & Arts Society who were seated on the Floor of the House:

Kahu Wendell Kalani Silva, Founder, and his wife, Sharon Silva; Trisha Kehaulani Watson, President; Suzanne Chun Oakland, Vice President; and Guy Sabilla, Executive Director.

The motion was put to vote by the Chair and carried, and H.R. No. 22 was adopted, with Representative Gates being excused.

At 12:18 p.m., the Chair declared a recess to allow the Members of the House to meet and congratulate the honorees.

The House of Representatives reconvened at 12:29 p.m.

"I am voting with reservations because I would like the three-year pilot program to include the districts of Molokai, Lanai, and Hana, Maui. These areas are rural and face similarly high rates of suspension, absenteeism, and exposure to trauma as places like Waianae. It is my belief that this program would be successful in improving the school and community culture of these districts."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. "I am voting in opposition to this bill because I believe that principals should not have the additional responsibility of tracking and reporting data. Schools already have measures in place to enforce and address exclusionary school discipline policies that fit their institutional needs."

Representative Tokioka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B.
