Representative McKelvey's written remarks are as follows:

"I stand with reservations on this measure. House Bill 1907, which seeks to spur aviation safety in the wake of the Kauai helicopter crash, is faulty as this is already a requirement through the Federal Aviation Administration (FAA). Although well intended and proposed to address safety issues, this bill has many shortcomings. If passed in its current form, this measure will punish innocent people and fail to bring about a reduction in harm because it does not address the underlying problem in a way that is realistic.

"Depending on meteorological conditions (MC) in terms of visibility, terrain, distance from cloud and ceiling, there are two sets of rules for flying any aircraft; visual flight rules (VFR) and instrument flight rules (IFR). Although commercial pilots are required to be IFR certified by the FAA, pilots generally use VFR when flying. VFR is permitted when pilots have sufficient visibility to fly an aircraft maintaining visual separation from terrain and other aircraft. The three most common causes of a helicopter crash are pilot error, lack of fuel, and mechanical failure. The recent crash involving Kobe Bryant showed that just because a pilot is instrument rated does not guarantee safety.

"Additionally, while this measure looks to increase safety for commercial pilots, it does not address flight schools whose pilots train students commercially. If this measure is passed, student pilots would no longer be able to be educated in Hawaii. Being a student pilot myself, I would therefore not be able to accrue student hours as a helicopter pilot in Hawaii, which forces me to find training in another state to obtain my pilot's license. I feel sorry for the *keiki* of Hawaii who will be obligated to leave home to pursue their dreams of becoming pilots. But then again, given that we're shipping our kids off to the continental US by-the-barrel for education anyway, another measure to increase educational-migration won't be noticed."

"I stand with reservations to House Bill 1606. While I appreciate the intent of the author wanting to facilitate a discussion allowing limited reciprocity in the licensure of spouses and dependents of military personnel, this bill creates a potential risk to Hawaii's consumers and devalues our professional licenses. Hawaii has developed a licensing scheme for various professions to protect consumers from harm by ensuring that their backgrounds are fully vetted and that they have received the proper education and training from accredited institutions. While it is noble to serve those who serve our country, it cannot be at the expense of the general welfare of our citizens.

"Unfortunately, the ability of the State to thoroughly examine all license holders in the manner prescribed within the bill would be arduous, if not impossible to complete. This can be especially troublesome if there are complaints or ongoing criminal investigations which are not revealed to the State before the mandatory issuance of a license because of due process or confidentiality issues.

"Furthermore, because licensure requirements vary from state to state, there are many professions in Hawaii which require specific accreditation from recognized national institutions that a military spouse or dependent may not have. Additionally, due to the nature of military service and the realities of deployments, military dependents and spouses often come and go in short periods of time, not allowing for the State to follow up on any complaints made while practicing in our jurisdiction.

"Like many other bills, although the ideals set forth are noble and with hard work the concerns could possibly be addressed, in its current form this bill has the potential to cause undue harm and untold damages to numerous people."

Mr. Speaker, my reservations are specific to Section 3 of House Draft 2, which continues to require, not give the option, but would require public school teachers to confiscate electronic smoking devices from students. May I remind this esteemed body that according to BOE and DOE policies, teachers are already authorized to confiscate contraband. An absolute requirement only adds to the tremendous amount of responsibilities teachers already have while they teach our *keiki*. I suggest that the language found in Section 1 of House Bill 2049, HD 1, which uses 'may' vs. 'shall,' be used instead."

Representative Tokioka rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No vote and just a real brief comment. The attorney general and others had concerns about the confiscation and the fees, so I'm sure it's going to get fixed along the way, but for right now it's a no vote. Thank you, Mr. Speaker."

Representative DeCoite rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am opposed to this bill because it puts an additional burden on our schools in confiscating electronic smoking devices. The superintendent of education has testified that this bill may inadvertently oppose the actions of the department which is the safety and well-being of students. The department is already working with the Department of Health (DOH) to educate students about making positive decisions about their health. In addition, DOH has stated that the bill requires DOE coordinate with DOH for the proper disposal of electronic cigarettes, however, it does not provide or manage any waste disposal services. *Mahalo*."

Representative Belatti rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Belatti's written remarks are as follows:

"I rise in support with reservations for House Bill 2504, House Draft 2.

"Balance billing or surprise billing is an important problem for the Legislature to tackle, especially in light of the escalating costs of health care year after year. The insurance commissioner and the administrator of the Hawaii Employer-Union Health Benefits Trust Fund raise significant concerns about the disincentives to good faith participation in dispute resolution processes involving nonparticipating providers that remain in this draft. As this legislation moves forward and with a focus on containing everescalating costs of health care faced by the consumer, I hope a more reasonable and balanced dispute resolution process is adopted."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2504, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HEALTH INSURANCE," was referred to the Committee on Finance, with Representatives Belatti, DeCoite, Har, Okimoto, and Tokioka voting aye with reservations, and with Representatives Holt and Takayama being excused.

Representative Takumi, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 658-20) recommending that H.B. No. 1886, HD 1, as amended in HD 2, be referred to the Committee on Judiciary.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1886, HD 2 be referred to the Committee on Judiciary, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1886, HD 2, entitled: "A BILL FOR AN ACT RELATING TO COFFEE LABELING," was referred to the Committee on Judiciary, with Representative McDermott voting no, and with Representatives Holt and Takayama being excused.

Representative Mizuno, for the Committee on Health, presented a report (Stand. Com. Rep. No. 659-20) recommending that H.B. No. 1661, HD 1, as amended in HD 2, pass Second Reading and be referred to the Committee on Judiciary.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1661, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Judiciary, with Representatives Holt and Takayama being excused.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1637, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," passed Second Reading and was referred to the Committee on Finance, with Representatives Holt and Takayama being excused.

Representatives Mizuno and San Buenaventura, for the Committee on Health and the Committee on Human Services & Homelessness, presented a report (Stand. Com. Rep. No. 662-20) recommending that H.B. No. 668, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 668, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Say rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative McKelvey rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McKelvey's written remarks are as follows:

"I stand in strong support of House Bill 668. The Department of Human Services (DHS) Med-QUEST Division's contract award poses severe issues for the people of Maui. By arbitrarily limiting people on the neighbor islands to only two plans, whereas those on Oahu will continue to have access to four plans, DHS Med-QUEST is exposing their bias. While this inequity may seem logical given the population differences, the reality is this ignorant decision to have only two plans for the neighbor islands and exclude THE biggest existing provider network on the island of Maui is not only problematic, but dangerous. This will result in thousands of patients being dumped on the backs of the remaining Maui providers, who are already stretched thin.

"When I recently pressed the DHS Med-QUEST Division on how they devised these numbers, rather than providing me with any shred of facts or figures all I received was allegorical data to which no concrete attribution can be made. The repeated line that years of research was done in conjunction with Maui providers seems suspect at best, especially considering that just last Tuesday, February 18, 2020, a Maui physician in a major physicians group notified me that they were never informed of any review by DHS Med-QUEST regarding these critical decisions. In fact, Maui physicians are just as outraged as I am at the absolute disruption this will cause to the healthcare delivery system on Maui. When pushed for ANY kind of data, besides alleged provider interviews, DHS Med-QUEST officials essentially said they studied places like Tennessee and then decided from the confines of their cubicles in Honolulu that restricting options for health care on Maui was the best decision, because it worked in a land-locked, southern state. DHS Med-QUEST has completely ignored the reality of Maui health care and has shown no regard for our unique geography. The rationale that neighbor island providers are somehow less equipped to handle four plans like providers on Oahu, is blatant Oahu-centric prejudice. Never mind the fact that they have done so for years with no problems.

"The shortage of medical providers on neighbor islands is well documented, especially in rural areas. Continuing to shrink the pool of available providers with no regard to patient care is not only unfair for the patients whose wait times will increase, but also for the medical providers whose patient loads are already reaching maximum capacity. I would argue that if the proposal had been based on real world evidence, it would show that in offering Maui patients the same number of plans as those on Oahu, the State would have the flexibility to accommodate the existing needs of Maui people.

"The concern that this house bill (HB 668 HD 1) will somehow interfere with ongoing purchase of service contracts is untrue. All that has occurred with these contracts thus far is that a bid award has been offered and is now being protested. As such, no contract has been signed, therefore no contract clause can be used to prevent the Legislature from protecting the interests of Maui Med-QUEST patients. In the past, the Legislature has taken similar action, as in the case of the EPOD bill which the Legislature overrode. The EPOD bill sought to administer all purchase of service contracts through electronic call centers, which would have resulted in the displacement of all eligibility workers on neighbor islands. At the time, the same concerns were raised, however the legality of such actions was upheld due to the potential public harm that would have occurred under that purchase of service contract. The Med-QUEST issue carries with it the same potential gravity of harm that the EPOD bill did, which is why it is appropriate that the Legislature strives to correct this issue.

"We need to fix this wrong before it goes into effect this summer, during the off session, when the Legislature will be unable to act. I am hoping that common sense will prevail, and DHS Med-QUEST will pull back the Request for Proposal (RFP) to reexamine its flawed set of anecdotal and outside-state data. I also hope that DHS Med-QUEST will work closely with the providers and the community on Maui in creating an RFP that is tailored to the unique health care landscape of Maui Nui."

Representative Mizuno rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support of this measure. The purpose of this bill is to assure that all neighbor island Medicaid residents have equal access to Medicaid, along with our Oahu residents. Here, that hasn't happened, as our neighbor island residents under Medicaid only have two choices of Medicaid health plans, either HMSA or UnitedHealthcare. I find it unfair and improper that Oahu residents have four choices of Medicaid health plans, Aloha Care, HMSA, Ohana Health Plan, and UnitedHealthcare. By diminishing the choices of our neighbor island Medicaid members to only two, compared to four on Oahu, is unfair and ultimately will displace 50,000 neighbor island Medicaid beneficiaries from the current health plan.

"Mr. Speaker, what I did is I looked at the press release by Department of Human Services trying to find out the rationale behind it, and the press release dated January 23rd, 2020 provides in relevant part, 'having a lot of health plans was confusing to our beneficiaries.'

"I'm a little bit perplexed myself because, is DHS saying that neighbor island beneficiaries are confused, so that's why they only have two health plans, and Oahu is not confused so they have four health plans? I've pondered this and I'm just a little perplexed, why is it that neighbor islanders are confused but Oahu residents are not confused. Again, I'm a little concerned.

"Finally, Mr. Speaker. We did all we can. I have the highest respect for Majority Leader. I was so fortunate to work with the Chair of Human Services & Homelessness as well as a number of members in trying to craft a bill that's fair and doesn't violate contract law. "And so this is what we did. We, in this bill, provided that an audit will be conducted, and we heard from DHS they welcome being transparent and accountable for everything, so that's part of the bill. In addition, we're establishing a legislative task force to look into this, to make sure that the decisions are not flawed. Next, we're also going to have the Legislature approve these changes in the future by two-thirds of the Senate, two-thirds of the House. Again, this is just a safeguard mechanism so this doesn't happen again. Fourth, we put a severability clause. Basically, what that means is that if there's any section in this bill that is contrary to federal law or violates CMS, it will be invalidated.

"Finally, Mr. Speaker, I just want to make two more points. This is not unprecedented, what we're trying to do. In 2010, the Legislature passed Senate Bill 2650, CD 1. This was over a Governor Lingle veto, we did an override. What did it do? The measure effectively prevented the Department of Human Services from closing all of its offices and establishing only two call centers, one in Honolulu and one in Hilo, to serve all the clients in our Department of Human Services. I don't think that was a smart decision, the Legislature stepped in, we did the right thing, we did an override, and it became Act 67 on April 29, 2010.

"Furthermore, one last bill that I want to talk about, the Legislature passed House Bill 1317 back on July 12, 2005 as Act 4. What did this bill do? Well this is what it did, it prohibited the Department of Human Services from taking any action to remove pharmaceutical benefits managers from managed care plans for Medicaid beneficiaries.

"So, Mr. Speaker, we've had cases where the Legislature has intervened when it comes to public policy and fairness. These are two examples. So for those reasons, I ask all members, I respect all your views and respect that we don't want to violate any contract. I respect all members to work with us and try to find a solution, that's why I support this bill. Thank you, Mr. Speaker."

Representative Belatti rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I'm very concerned about the constitutionality of this bill. And in addition, what the previous speaker just said was in the bill is not currently in the draft as placed before the members. Thank you."

Representative Johanson rose to speak in support of the measure with reservations, stating:

"Thank you, with reservations and a brief comment. This would probably be a substantial change to the way we do procurement, and this had not had a hearing in the Labor Committee with jurisdiction over procurement. Thank you."

Representative Ichiyama rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, may I request a ruling on a potential conflict? My spouse works for a health insurance plan that offers Medicaid plans," and the Chair ruled, "no conflict," and that the ruling would extend through *sine die*.

At 1:05 p.m., Representative Say requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:07 p.m.

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support of our Health Chair and his efforts to remedy perhaps and unintended consequence of the bidding process happening in the Health and Human Services Department. This situation right now leaves Medicaid Maui residents, 10,000 Medicaid patients, out of their access to 34 primary care physicians and 71 specialists in the closed Kaiser network. This kind of flood into the rest of the remaining healthcare system is completely untenable and could create as much as sixmonth wait times for general practitioner doctor's appointments. So, this is

going to make an undue burden on Maui's already strained healthcare system. Thank you."

Representative McKelvey rose to respond, stating:

"Thank you, Mr. Speaker. Still in support, second time. First, I would like to adopt the words of the Chair of Health as if they were my own, in addition to the good Representative from Kihei. And also to help assuage contract clause fears, no contract has been signed yet, Mr. Speaker, it's an award that's under protest. Thank you very much," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 668, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTHCARE," passed Second Reading and was referred to the Committee on Finance, with Representatives Belatti, DeCoite, Har, Johanson, Okimoto, Perruso, and Tokioka voting aye with reservations, with Representative Say voting no, and with Representatives Holt and Takayama being excused.

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 663-20) recommending that H.B. No. 2035, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2035, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, no vote please, brief comment. With the impending climate crisis upon us, we cannot choose ranching over forest lands. *Mahalo*."

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote on SCR 663 and a couple of comments. This would require the Department of Land and Natural Resources to turn over certain lands to the Department of Agriculture. It's about 10% of its land from DLNR. I'd like to just note a couple of things, that agricultural lands under Department of Agriculture are not as regulated as pastoral lands regarding the conservation of ecosystems. DLNR pastoral lands contain old growth koa forests that are put at risk of deforestation under DOA cattle ranching.

"The other thing is, you look at the list of the opponents to this measure, in addition to DLNR, of course, you have the Office of Hawaiian Affairs, Nature Conservancy, Sierra Club of Hawaii, American Bird Conservancy, Conservation Council for Hawaii, and several Hawaiian organizations. I don't think this is a good policy if we want to preserve our lands here. Thank you."

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, in support, brief comment. Mr. Speaker, having been in that hearing yesterday, you can't help but think that something that this body said in 2003, 17 years later is still being discussed, that's what this thing is all about. They were supposed to turn over their lands, and we got down into a definition of whether ag lands or pasture lands, pasture lands, ag lands, it became a definition. But really, if you really put it in a bumper sticker, it's basically conserving the land or letting the farmers, i.e. the cattlemen, raise beef.

"We have a goal to be self-sufficient. I'm sure all the members remember that we wanted to have local dairies survive. In this particular period into the early 2000s, we had 14 dairies. Mr. Speaker, we didn't listen to their cries and you know how many dairies we got left now? One, and it's in foreclosure.

"So, if the cattlemen are saying, hey guys give us what you promised us in 2003 so we can survive, as one cattlemen said, we just put a million dollars to get our water supply for our cattle and my lease is so short, I'm not even going to be able to amortize it to get my money back.

"So, if we want our cattle people to survive, and there's not really that many left either, we've got to give them a break. They don't rip up the land, they take care of it, they water it. And if we want to eat beef that's made locally, we've got to cut them some slack. But we also have to take care of the environment obviously, but we don't want to cut them out, because that's the only source of really substantial beef that we have.

"For those reasons, Mr. Speaker, I think this is a good bill, and it's going to help the cattle industry survive, hopefully more than the 14 years that we lost 14 of the dairies and one left that's in foreclosure. Thank you."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Lowen rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No vote and brief comments. I don't see this as a choice we have to make between ranchers and conservation. I think that DNLR is committed to continuing to work with farmers to lease these lands. But I do think that keeping them under DLNR preserves the option to look at these lands in the future for reforestation, should we need to do that. I think that keeping that option on the table is important, and I support the following bill, which is a more balanced solution to this issue."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, reservations, Mr. Speaker. It just appears that, because it hasn't happened, the DLNR doesn't want to do it, so it's kind of like a hostile takeover. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2035, HD 1, entitled: "A BILL FOR AN ACT RELATING TO NON-AGRICULTURAL PARK LANDS," passed Second Reading and was referred to the Committee on Finance, with Representative McKelvey voting aye with reservations, with Representatives D. Kobayashi, Lowen, Perruso, Thielen, and Wildberger voting no, and with Representatives Holt and Takayama being excused.

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 664-20) recommending that H.B. No. 2358, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2358, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AUTHORIZING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO LEASE PASTURE LANDS ON TERMS THAT PROMOTE COLLABORATIVE BENEFICIAL USE FOR FORESTRY, WILDLIFE, RECREATIONAL, AND FOOD PRODUCTION PURPOSES," passed Second Reading and was referred to the Committee on Finance, with Representatives Holt and Takayama being excused.

Representatives Lee and Takumi, for the Committee on Judiciary and the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 665-20) recommending that H.B. No. 2590, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 2590, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Cabanilla Arakawa rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition and I would like to make a comment. Although this bill is well-intended, I think that this should be an initiative that will be given, or should the Federal Government undertake, or the manufacturers themselves and this autonomous vehicle. I believe that the appropriation that DOT is asking will be better served by spending the money on traffic mitigation initiatives, especially in West Oahu. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, in full support, and commending the author of this bill of which maybe five years ago I introduced a bill saying, hey this is the future, this is A.I., this is artificial intelligence. Ninety percent of all accidents are human caused. This is going to save lives, it's going to create a wealth of mobility for the disabled, for the blind, for those who are not able to get around, and it is going to make our freeways less congested. But we got to test it.

"And by the way, we are way, way, way, way behind in terms of what Palo Alto is doing, what the UK is doing, and what China is doing to relieve congestion because of faulty people called human beings who're driving those cars who drink, who sleep, who do things that are untoward for safety. For those reasons, Mr. Speaker, we got to catch up and this bill gives us the chance to do that."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 2590, HD 2, entitled: "A BILL FOR AN ACT RELATING TO AUTONOMOUS VEHICLES," was referred to the Committee on Finance, with Representative Cabanilla Arakawa voting no, and with Representatives Holt and Takayama being excused.

Representatives Lee and Takumi, for the Committee on Judiciary and the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 666-20) recommending that H.B. No. 2043, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 2043, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative McDermott rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm in opposition, I do have some brief concerns. It appears to me again, this is chipping away at parental rights. And I think parents should only be excluded from the treatment of their children, or not a partner, if they are the cause of the abuse. And if they're the cause of the abuse or they're creating the abusive situation, we should get CPS in there to remove them from the parents, because they're in danger.

"But here we have a bill that allows an unlicensed, unlicensed healthcare professional, under the supervision of a licensed healthcare professional, to provide treatment to a minor without parental consent or notification. What could possibly go wrong there? Well, I see a myriad of things, and it strikes me wrong on many issues, but mainly the parental consent. If the parents are a problem, let's get CPS in there and find out. Otherwise, parents should be part of a holistic process to move the child forward. Second reading, I'll just, thank you."

Representative Cachola rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 2043, HD 2, entitled: "A BILL FOR AN ACT RELATING TO ADOLESCENT MENTAL HEALTH CARE," was referred to the Committee on Finance, with Representatives Cachola, DeCoite, Matsumoto, Okimoto, and Ward voting aye with reservations, with Representative McDermott voting no, and with Representatives Holt and Takayama being excused.

Representatives Lee and Takumi, for the Committee on Judiciary and the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 667-20) recommending that H.B. No. 583, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 583, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Cachola rose to disclose a potential conflict of interest, stating:

"Request for a ruling for a possible conflict of interest. Relating to primary caregivers, I have two doctors in my family who are primary caregivers," and the Chair ruled, "no conflict," and that the ruling would extend through *sine die*.

Representative Cachola continued, stating:

"May I request that all bills that have something to do with doctors, that I should be coming up with no conflict also?"

The Chair addressed Representative Cachola, stating:

"No, Representative, you need to declare a potential conflict as to each bill as it comes up on the Floor, there is no blanket ruling."

Representative Cachola continued and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 583, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CANNABIS FOR MEDICAL USE," was referred to the Committee on Finance, with Representatives Cachola and Ward voting aye with reservations, with Representative Okimoto voting no, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 668-20) recommending that H.B. No. 2565, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2565, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2565, HD 2, entitled: "A BILL FOR AN ACT RELATING TO PESTICIDES," was referred to the Committee on Finance, with Representative Okimoto voting aye with reservations, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 669-20) recommending that H.B. No. 2745, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2745, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa. Representative Perruso rose to speak in support of the measure with reservations, stating:

"With reservations. I support regulating face surveillance, but I don't think that the police should be exempt, given the tendency towards gender and racial bias. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2745, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FACE SURVEILLANCE," passed Second Reading and was referred to the Committee on Finance, with Representative Perruso voting aye with reservations, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 670-20) recommending that H.B. No. 2749, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2749, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PROSECUTORIAL TRANSPARENCY," passed Second Reading and was referred to the Committee on Finance, with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 671-20) recommending that H.B. No. 2174, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2174, HD 2, entitled: "A BILL FOR AN ACT RELATING TO OPERATING A VEHICLE UNDER THE INFLUENCE OF AN INTOXICANT," was referred to the Committee on Finance, with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 672-20) recommending that H.B. No. 2127, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2127, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LICENSING," passed Second Reading and was referred to the Committee on Finance, with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 673-20) recommending that H.B. No. 2607, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2607, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2607, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC ORDER," passed Second Reading and was referred to the Committee on Finance, with Representative Perruso voting no, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 674-20) recommending that H.B. No. 2216, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2216, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa. Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2216, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HAWAIIAN HOME LANDS," was referred to the Committee on Finance, with Representative Okimoto voting aye with reservations, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 675-20) recommending that H.B. No. 2459, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2459, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, no vote with a brief comment, or should I say a brief plea to the next committee, Finance, to keep this bill alive. Actually, it was a better bill in the beginning in the Health Committee, it basically gave an optout or a 'conscientious objector' option for those mothers who didn't want their kids to get, for example, 11, 12, 13-year-olds to get HPV, *et cetera*. But to keep it alive, the good Chair of Health made it a study, which is good.

"But what I'd love to do is to plead to the Finance Committee to say, okay, we'll do the study, but don't implement these July mandatory HPV and all these other multitude of shots. Which, Mr. Speaker, Robert Kennedy has got the data that says the study is probably going to be based upon a lot what he has because he's got more of the information that is upfront and close to those mother's who've got the kids who have experienced difficulties. And I know that I didn't say his name, but I know the author of this bill knows exactly what I'm talking about when it comes to these things are very real.

"The chemistry of our body is basically a factory of different hormones and different enzymes and different receptors and all kinds of other things that we don't even know about, the same way we don't know all the stars and the moons and all the things under the water. We haven't explored that.

"What this is saying, that the CDC and the Department of Health knows better than these empirically proven cases where people are either being put into coma, frozen, some are, not frozen, having heart attacks, and other kinds of just basically lapsing into rubber vegetables for periods of time and then being dysfunctional for the rest of their lives.

"This is certainly something we should yield. Again, as I said earlier in my other speech, we should not be considered anti-vaxxers, we're really prochoice. Even though on the other issues I'm not pro-choice, on this issue, this is really a pro-choice issue for parents to have control over their kid's bodies, at least until they become of age.

"So, Mr. Speaker, I would again plead to the next committee, hear it but try to hold back the reins of the department for another year or so, we can pull back the HPV and these other mandatory shots, just as a compassion for all those multiple, multiple families that step forward to plead with the legislators on this Floor. For those reasons, Mr. Speaker, we can do better and hopefully we will do. Thank you."

Representative Belatti rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations, please. Mr. Speaker, I think this bill is problematic, but I would support it, I will however say that as our state now faces a very real threat of coronavirus, I think that we should allow the Department of Health to do what they need to do and not be distracted by conducting yet another study or doing anything else. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2459, HD 2, entitled: "A BILL FOR AN ACT RELATING TO MEDICAL AUTONOMY," was referred to the Committee on Finance, with Representative Belatti voting aye with reservations, with Representative Ward voting no, and with Representatives Holt and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 676-20) recommending that H.B. No. 2128, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2128, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2128, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONS," passed Second Reading and was referred to the Committee on Finance, with Representative Okimoto voting no, and with Representatives Holt and Takayama being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 677-20) recommending that H.B. No. 2200, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2200, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Quinlan and Takayama being excused.

Representatives Takayama and Lee, for the Committee on Public Safety, Veterans, & Military Affairs and the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 678-20) recommending that H.B. No. 2709, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 2709, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Morikawa.

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 2709, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE UNIFORM PROBATE CODE," passed Second Reading and was placed on the calendar for Third Reading, with Representative McDermott voting no, and with Representatives Quinlan and Takayama being excused.

Representatives Takayama and Lee, for the Committee on Public Safety, Veterans, & Military Affairs and the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 679-20) recommending that H.B. No. 1902, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 1902, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Morikawa.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, thank you. In opposition, brief comments. I want to thank the Chair, very inclusive, willing to listen to ideas, very open, and as a member of the minority, it's a pleasure to work with him and I want to help him on his prison reform and other things. This bill is a good bill and bad bill. And I think it encapsulates the entire firearms debate in one measure.

"One measure wants to address the mental health aspects, particularly of minors. These kids, and I think there was a case in Florida where they develop a kill list, they're in trouble constantly, these are the kids who're going to juvenile hall, who're putting cats in microwaves, things of that nature. Just because they turn 19 doesn't mean they're mentally stable,

should be able to purchase a long gun or something of that nature. So, I applaud that.

"The other side of the bill is to reduce the magazine size from 20 to 10. Some people might say it's an illegal taking because you're going to have to turn them in. Or we're going to turn honest people into criminals because they won't turn them in. But, I didn't see a real need why we needed to reduce the size, other than to make ourselves feel good about nibbling at this issue around the edges.

"But, something during the hearing, when they got up and talked about the mental health issue, only two people testified against that. It was the NRA guy, of course that's his job, and the Office of the Public Defender, and she was concerned the language was too vague, which I certainly understand. The room was full of NRA folks, none of them, not a single one got up and testified against keeping the mentally unstable from getting firearms. Not a one. I really found that remarkable because when we switched over to the magazines, they were all up in arms.

"So, in short, nobody has a problem addressing the crazies, the behavior issue, and I think that's where we need to focus on moving forward. But when you address the tool, the law-abiding folks have a problem with that and they're going to resist, always. So, for second reading, those are my comments, sir."

Representative Quinlan rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Okimoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Okimoto's written remarks are as follows:

"Thank you, Mr. Speaker. In support with reservations for House Standing Committee Report No. 679-20, House Bill 1902, HD 1. Mr. Speaker, I have concerns about the broad language found in subsection (g) found in Section 2 of this draft. For example, a minor diagnosed with an eating, sleeping or gambling disorder would be prohibited from owning a firearm unless they were medically documented to be no longer adversely affected by the disorder, or no longer deemed a danger to themselves or others. I also find it ironic, as progressive as this body claims to be, that it would also prohibit minors diagnosed with gender dysphoria from owning a firearm. Finally, Mr. Speaker, a magazine restriction on law abiding, responsible firearms owners will just give the upper hand to criminals who could care less about how many rounds they have in their magazine. For these reasons, Mr. Speaker, I have strong reservations for this measure."

Representative D. Kobayashi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I want to declare a potential conflict. Gun owner, member of the NRA and HRA," and the Chair ruled, "no conflict," and that the ruling would extend through *sine die*.

Representative DeCoite continued in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am opposed to this bill because it will turn law abiding citizens into criminals. The bill will prohibit large capacity magazines for all firearms and not just for pistols. Rifle magazines that hold 20-30 rounds are legal in Hawaii and number in the thousands. Owners of these firearms would become criminals overnight with this bill. *Mahalo*."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ward's written remarks are as follows:

"Mr. Speaker, with all the mass shootings taking place in the country it's important that we address the mental health crisis, which I believe to be the problem. Not guns. This bill prohibits certain individuals from owning a firearm if, as a minor, they were diagnosed with behavioral, emotional, or mental disorders or deemed to be a danger to themselves or others. However, what I don't agree with, is limiting the magazine capacity for law abiding citizens. Limiting the magazine capacity isn't addressing the mental health crisis, which is the root of the problem. This is why I'm voting with reservations. *Mahalo*."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kitagawa rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Eli rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Say rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Yamane rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 1902, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIREARMS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Aquino, Cullen, Gates, Har, Kitagawa, D. Kobayashi, Matsumoto, McKelvey, Okimoto, Say, Tokioka, Ward, and Yamane voting aye with reservations, with Representatives DeCoite, Eli, and McDermott voting no, and with Representatives Quinlan and Takayama being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 680-20) recommending that H.B. No. 2256, HD 1, as amended in HD 2, pass Third Reading.

By unanimous consent, consideration of Stand. Com. Rep. No. 680-20 on H.B. No. 2256, HD 2, was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawaii, printed copies of H.B. No. 2256, HD 2, were made available to the Members of the House.

At this time, the Chair stated:

"Members, on page 50, beginning with SCR 681-20 through page 51, House Bill 1631, House Bill 2500, House Bill 2537, these are deferred one legislative day."

Representative Yamane, for the Committee on Water, Land, & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 681-20) recommending that H.B. No. 2192, HD 1 pass Third Reading.
