The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:11 p.m., with Speaker Saiki presiding.

The invocation was delivered by Dr. Trisha Kehaulani Watson-Sproat and Mr. Matt Sproat, after which the Roll was called showing all members present with the exception of Representatives Cabanilla Arakawa, DeCoite, and Holt, who were excused.

"Mr. Speaker, in opposition. I appreciate the intent and I know that the number has dropped drastically since the last year, but the bill currently as it is still has no protections for small business owners. And I just am a believer that the market should drive or dictate the price of the wages, not the Legislature. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. Representative Okimoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, in support with reservations. I stated in the last committee, the joint committee hearing that we had, I, of course, am a supporter of education and early childhood education. And I appreciate all the work that was put into the bill by both the committee chairs and the intent of this bill. However, the way the bill is stated there are still many unanswered questions.

"I feel that we have a teacher shortage that we are dealing with, and the comments I heard in committee hearing was that we're going to take teachers from their current positions and shift them around, which doesn't answer, again, the question that we currently are facing with our teacher shortage. And I felt that that question hasn't been answered.

"I did have concerns about the requirement of standardized testing, standardized assessments, as well as the quality of the education these programs that we're planning on putting into place.

"So, while I greatly appreciate the time and the effort that was put into the bill, in my term of service with the DOE, when we make goals, we make sure that they're measurable and achievable. And I felt that with this bill, the way it's stated, we are not going to be able to do that in the right manner. So, for those reasons, I am voting with reservations. Thank you."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative McDermott rose to speak in support of the measure with reservations, stating:

"Reservations, permission to make a few comments. It's a well-intended bill, great. We've been trying to do early education here for several years, maybe almost a decade. I think the open doors component is fantastic, that is one of the best programs we have in the state, the open doors program. I would rather just see us undergird that, buttress that, then try to create something new, because we're not doing the basics correctly yet. And it's not anyone's particular fault in here, it's just that K-12 still needs more focus to deliver an equitable education to all the kids who're in school. Before we go start on this huge undertaking, which is a great idea, maybe we can get to it in 10, 15 years, after we get K-12 straightened out. Thank you, sir."

And Mr. Speaker, I'd like to see this thing eventually say, yes, naming rights are part of our entrepreneurial perspective about saving taxpayers money as well as using what otherwise all stadiums do if it's of substantial importance, such as Aloha Stadium. Thank you."

Representative Okimoto's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to House Standing Committee Report No. 817-20, House Bill 2485, HD 1. This bill proposes to require the Board of Trustees of the Employees' Retirement System to conduct a study to determine and provide retirement benefits for Hawaii National Guard members who are activated under state active duty orders.

"Members of the Hawaii National Guard are entitled to earn a retirement check upon reaching the age of 60 as long as they complete 20 years of qualifying service. At a minimum, qualifying service includes participating in monthly drills and annual training, and attending required schools, such as basic training.

"Additional qualifying service would also include federal orders issued pursuant to Title 10 or Title 32 of the United States Code. Depending on the type and length of service, the retirement age could be reduced. For example, a year of service under Title 10 orders would allow a member to collect a retirement check at age 59.

"Unfortunately, state active duty orders issued by the Governor are not considered qualifying service for federal retirement. State active duty is considered a militia status paid for and controlled by the State. Members of the National Guard in this status are classified as state employees by the Federal Government. Furthermore, members of the National Guard are exempt from state civil service pursuant to Chapter 76 of the Hawaii Revised Statuses.

"Mr. Speaker, I thank our colleague from Mililani for introducing this bill because he understands that service performed under state active duty orders is not considered qualifying service for retirement purposes.

"However, I must oppose this bill because the Board of Trustees of the Employees' Retirement System should not be required to perform a study for non-beneficiaries. The State of Hawaii already has two retirement plans available which could qualify state active duty service for part-time National Guard members.

"In his testimony submitted before the Committee on Finance on February 19, 2020, the executive director of the Employees' Retirement System suggested an amendment to the bill which would allow part-time members of the Guard to participate in PTS Deferred Compensation Retirement Plan, which is administered by the Department of Human Resources Development.

"This body could also amend this bill to allow part-time members of the Guard, while serving under state active duty orders, to participate in the state's IRC 457 Deferred Compensation Plan if they are on state active duty orders for more than 29 days.

"Finally, Mr. Speaker, Members of the Hawaii National Guard are also allowed to participate in the federal Thrift Savings Plan which is a retirement savings and investment plan for federal employees and members of the military. "This study is unnecessary because there are a sufficient number of state and federal retirement plans available to members of the National Guard. I cannot support any bill, even though this one only calls for a study, that could expose the ERS to additional risk beyond its existing \$13 billion unfunded liability. For these reasons, I stand in opposition."

"Mr. Speaker, in opposition and a brief comment, please. Young Brothers has come to the PUC asking for rate hikes in excess of I think 34%. The last time they asked for a raise in their rates for neighbor island transport, the consumer advocate offered Young Brothers hundreds of pages in recommendations for efficiency improvements, none of which have been implemented, and they're still coming for money from both the Legislature and in rate hikes. Thank you very much."

And I think the legal citizens of the State of Hawaii would rather have that money go to projects that benefit them. And at the risk of being called a xenophobe, I want you to know that I married an immigrant, so I don't have any hatred towards these folks, in fact I love them. But this is, one last time, it's a legal fund to provide money for attorneys for illegal aliens, illegal immigrants. Thank you, sir."

ANNOUNCEMENTS

At this time, the Chair stated:

"The Chair has an announcement. Members, as you know, there are many important policies that we are considering this year. The responsibility for us in the House is our ability to foresee and to adequately prepare for unanticipated events. Recent global and national events surrounding COVID-19 loom over all of us. The World Health Organization just raised its prediction of the global spread of the virus to very high. Hawaii's Department of Health, Department of Defense, and other agencies have been focused on health and medical preparedness. But just as importantly, we also need economic and financial preparedness.

"Hawaii will be hit hard because of our proximity to Asia and our fragile economy that relies heavily on tourism and imports. The Department of Business, Economic Development and Tourism reported a 7.4% drop in international passengers to Hawaii just in February, and also estimated a loss of over \$23 million in visitor expenditures due to the temporary suspension of flights to and from South Korea. Because of our heavy reliance on tourism and imports, we must prepare for the financial and economic impact on Hawaii's residents, businesses, and government operations.

"If you will recall that during the recession of 2008 and 2009, Hawaii was faced with a shortfall of \$2.1 billion. To account for the loss, difficult decisions were made. The state implemented furlough Fridays and reduced the public school week to four days. The State cut millions of dollars for critical mental health, adult dental, social service, housing, homeless, and environmental programs. Public employees were subjected to a 5% salary reduction.

"In anticipation of what may be ahead of us, on Tuesday I will be asking the House of Representatives to adopt a resolution that creates a Select House Committee on COVID-19 Economic and Financial Preparedness. The committee will identify the potential economic and financial impact to Hawaii, develop short-term and long-term mitigation plans, and monitor conditions and outcomes.

"Not only is it imperative that we all work together to ensure the health and safety of our citizens, but we must also work to secure Hawaii's economy and financial viability. So, members, thank you in advance for your consideration of this initiative."

Representative Ward: "Mr. Speaker, your minority looks forward to working with the majority and fulfilling the safety and the health concerns for the people in the State of Hawaii. Thank you."
