The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:03 p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Mr. Bixby Ho, Executive Vice President, Junior Chamber International Hawaii, after which the Roll was called showing all members present.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Fifth and Twenty-Sixth Days was deferred.
