THIRTY-SECOND DAY

Friday, March 13, 2020

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:02 p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Mr. David Borja Enriquez, a student of the William S. Richardson School of Law, after which the Roll was called showing all members present with the exception of Representatives Eli, Gates, McKelvey, and Thielen, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirtieth and Thirty-First Day was deferred.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

The following resolution (H.R. No. 187) was announced by the Clerk and the following action taken:

H.R. No. 187, entitled: "HOUSE RESOLUTION RECOGNIZING KAPENA FOR THEIR LIFELONG ACHIEVEMENTS AND PROFOUND IMPACT ON ISLAND MUSIC," was jointly offered by Representatives Tokioka, DeCoite, Har, Holt, Kong, Nishimoto, Quinlan, and Say.

Representative Tokioka moved that H.R. No. 187 be adopted, seconded by Representative Har.

Representative Nishimoto shared the story of Kapena, which began when Kelly Boy DeLima put a band of students from Kaimuki High School together and entered the Brown Bags to Stardom competition unsuccessfully in 1984 and 1985, but later went on to record 20 albums and win multiple Na Hoku Hanohano awards.

Representative Say recognized Kelly Boy and Kapena as one of the brightest stars in local island music, topping the charts locally, nationally and internationally in the '70s and '80s.

Representative Tokioka honored Kapena for their lifelong achievement and profound impact on island music; recognized the band as an institution that embraces what islanders fell in love with when fans first heard the unique sound of their "electrifying" music; shared how the band has evolved over the years to now include Kelly Boy's three children and bring a new, fresh Kapena sound with new original music, winning multiple Na Hoku Hanohano awards including Album of the Year and Group of the Year; and congratulated and introduced members of Kapena who were seated on the Floor of the House:

Kelly Boy DeLima, Founder and Leader, Lead Vocals and Ukulele, with the group since its inception in 1984;

Kapena DeLima, Keyboard, Vocals, Drums, and Musical Director, with the group for over 16 years; Owner, Head Engineer, and Producer of Bu Print Studios; 2013 Na Hoku Hanohano award winner for Engineer of the Year; solo artist and 2014 Na Hoku Hanohano award winner for Contemporary Album of the Year;

Kalenaku DeLima, Keyboard, Vocals, Graphic Designer, and Writer, with the group since 2006; solo artist with her own Na Hoku Hanohano award nomination; Leolani "Lilo" DeLima, Vocals, Bass Guitar, and Songwriter, with the group since 2009; solo artist with her own Na Hoku Hanohano award nomination; and

Leolani DeLima, Manager, Public Relations Director, CEO, and wife of Kelly Boy.

Representative Matsumoto thanked Kapena for the opportunity to dance with them at the Halekulani and honored them for their music and spirit of *aloha*.

The motion was put to vote by the Chair and carried, and H.R. No. 187 was adopted, with Representatives Gates and Thielen being excused.
