RE: Temporary Suspension of Hearings and Floor Sessions

House and Senate Leadership have met and agreed to temporarily suspend all public hearings and floor sessions effective Tuesday, March 17, 2020. This action conforms with the recommendations of the Hawaii State Department of Health and the Federal Centers for Disease Control and Prevention to practice social distancing by avoiding public events and large gatherings.

In light of the current situation's changing nature, the suspension will be until further notice, subject to written call by the President and Speaker. Once it is determined that hearings and floor sessions may resume, a revised legislative timetable will be released. Until then, all lateral and decking deadlines are also suspended.

The Legislature will remain open during the suspension and other operations are expected to continue. Working guidelines will be issued as soon as practicable.
