

**FORTY-SEVENTH DAY****Monday, June 29, 2020**

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, convened at 12:07 p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Representative Tom Brower, after which the Roll was called showing all members present, with Representatives Creagan, DeCoite, Har, Lowen, Matayoshi, Matsumoto, McKelvey, Perruso, Quinlan, and Thielen participating remotely via videoconference.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-Sixth Day was deferred.

**SENATE COMMUNICATIONS**

The following communications from the Senate (Sen. Com. Nos. 541 and 542) were received and announced by the Clerk:

Sen. Com. No. 541, transmitting H.B. No. 2500, SD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," which passed Third Reading in the Senate on June 26, 2020.

No. 3054, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIREARM REGISTRATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Aquino, Creagan, Hashimoto, McKelvey, and San Buenaventura voting aye with reservations, and with Representatives DeCoite, Eli, Har, Kitagawa, Kong, Matsumoto, McDermott, Okimoto, Quinlan, Say, Tokioka, Ward, and Yamane voting no.

**ANNOUNCEMENTS**

Representative Onishi: "Thank you, Mr. Speaker. Again, I'd like to happily announce that Airbnb and Kauai County have signed an MoU regarding the management of short-term vacation rentals."

Representative Luke: "Thank you, Mr. Speaker. This is kind of an unusual announcement, but I just wanted to take the time to respond to Director Espinda's letter relating to the Fernhurst closure. He claimed that it's due to the Legislature's reduction in PSD funds that he is being forced to close Fernhurst."

"The Legislature has been more lax with PSD funding than any other department. Partly because PSD has a lot of flexibility because of the

movement of inmates from Hawaii to Arizona and out-of-state-inmates. And because of that, unlike any other department, PSD has gotten a significant amount of latitude in flexibility of funds, all the funds that was removed from PSD and any other department were lapsed funds and not impacting any direct services.

"So, as Chair of Finance, I'm very disappointed in the letter that was sent by the director in response to the Legislature's request to keep Fernhurst open. And as a result, we will be taking a closer look at the budget. Because in the past, they have had surplus and slush funds of over \$25 million. At some point they requested that they keep the slush funds because of various movements that they wanted to make between Hawaii and Oahu. So, on behalf of the Legislature, we wanted to show our deep regret to the director's letter. Thank you."

Representative Ward: "Mr. Speaker, that clearly was an unusual announcement. I have an even more unusual announcement. What is she talking about?"

Representative Luke: "Representative Ward, please read your emails. Thank you."
