Thursday, February 11, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at 12:01 p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Greggor Ilagan, after which the Roll was called showing all members present, with Representatives Har, LoPresti, and Matsumoto participating remotely via videoconference, and with the exception of Representative Ohno, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fourteenth Day was deferred.

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because while teacher housing is needed in rural areas, this bill will limit renting teacher housing to those with less than six years of public school teaching experience in Hawaii. This bill leaves out those teachers who may have many more years of experience and who also may need housing. All teachers who face challenges in finding affordable housing in rural areas should have access to no cost or low-cost teacher housing provided by the DOE. *Mahalo.*"

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 525, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TEACHER HOUSING," passed Second Reading and was referred to the Committee on Housing, with Representatives DeCoite, Har, and Okimoto voting aye with reservations, and with Representative Ohno being excused.

Representative Woodson, for the Committee on Education, presented a report (Stand. Com. Rep. No. 160) recommending that H.B. No. 690, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative McDermott rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I have reservations and a few comments. I certainly support the aspirational goals of this measure, but I am not sure what the metrics are you would use to determine them, that's my concern. And then, does it rise to the level where we are messing with the Constitution? Thank you, sir."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, further to my colleague's comments of Ewa Beach, I have reservations because it looks like, to the man on the street, the woman on the street, that if we want to have an efficient and, what are the words that they use here, school system that is of efficiency and thorough, you mean you don't have it now? What are you guys doing at the DOE?"

"So, in a way it could backfire and kind of embarrass us rather than make us look like, yeah we're going to make an efficient and a very thorough DOE. With those things, reservations, or we could wordsmith it to be a little bit less loosey-goosey, if you will. Thank you, Mr. Speaker."

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 690, HD 1, entitled: "A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE X, SECTION

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Wildberger rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ganaden rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kapela rose to speak in opposition to the measure, stating:

"No vote, Mr. Speaker, and a comment, if possible. I do appreciate the need to protect Hawaii's critical electrical infrastructure, but I cannot in good conscience support this bill. House Bill 686 is modeled on legislation that is proposed by the American Legislative Exchange Council that has been used by fossil fuel and energy companies in other states to criminalize climate change demonstrators and indigenous rights activists. It does so in a draconian way by grading the new offense of trespassing on electrical infrastructure as a Class C felony, something that is much higher than the corresponding penalties for standard trespassing that already exist in our state law.

"The Legislature should not be eroding the First Amendment rights of environmental justice and Native Hawaiian rights activists, especially in the midst of a climate emergency and serious discussions about the preservation of our *āina*. Instead, we should be making sure that we come together to deliver a green future that sustains our islands for generations to come. Thank you, Mr. Speaker."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. As this is coming to Judiciary, I look forward to the conversation on the concerns there. But until then, with reservations."

Representative LoPresti rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, thank you. Reservations. The same, since I'm on Judiciary, I look forward to the discussion there. But in the meantime, reservations, please."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 686, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CRITICAL ELECTRICAL INFRASTRUCTURE," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Gates, LoPresti, and McKelvey voting aye with reservations, with Representatives Ganaden, Kapela, Perruso, and Wildberger voting no, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 168) recommending that H.B. No. 1292, as amended in HD 1, pass Second Reading and be referred to the Committee on Labor & Tourism.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1292, HD 1 pass Second Reading and be referred to the Committee on Labor & Tourism, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1292, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HAWAII NATIONAL GUARD RETIREMENT BENEFITS," passed Second Reading and was referred to the Committee on Labor & Tourism, with Representative Okimoto voting aye with reservations, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 170) recommending that H.B. No. 398, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 398, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Ganaden rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support. Mr. Speaker, the writ of *habeas corpus* is enshrined in law. It is a basis of our democracy. It means, in brief, to bring me the body. The government's capacity to bring an individual before it for rulemaking, for decision making, it is the basis of much of our state and federal constitutions.

"This bill clarifies the two compacts which allow citizens of the State of Hawaii to be housed in jurisdictions outside of the state. It clarifies that the jurisdiction of the State of Hawaii travels with the body, it goes with our prisoners. It doesn't matter if they're in Arizona, or New York, or Mars, really. It means that the State of Hawaii retains the capacity to bring them back home. Thank you, Mr. Speaker."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 398, HD 1, entitled: "A BILL FOR AN ACT RELATING TO INMATES," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Okimoto voting aye with reservations, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 171) recommending that H.B. No. 621, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 621, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Perruso rose to speak in support of the measure with reservations, stating:

"I stand in strong support, except I have a request for the next committee. I noted that advocates had some concerns about the makeup of the working group that's discussed in this measure, and I concur with those concerns. So, I guess my position is with reservations."

Representative Kapela rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 621, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE OAHU COMMUNITY CORRECTIONAL CENTER SITE," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Kapela and Perruso voting aye with reservations, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 172) recommending that H.B. No. 1080, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1080, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ganaden rose to speak in support of the measure, stating:

"To my knowledge, Mr. Speaker, this is the first time that this has come before a debate before the House of Representatives. My much thanks to the Legislative Reference Bureau for doing some legal research, along with my office.

"In strong support. In 1989, when House Bill 411 came before this body, there was no debate. It authorized the director of Corrections to transfer inmates out of state. In 1992, when Senate Bill 2900 came before this body on the 46th day, it had no debate. The same happened in 1994, it passed without debate on the 36th day.

"Mr. Speaker, it is well documented that the transfer of inmates out of state has a disproportionate impact on indigenous peoples. Specifically, here in the State of Hawaii, on Native Hawaiians. A 2010 study by the University of Hawaii as well as Georgetown University documents that. It is a global issue.

"I would like us to move beyond blame. I think that there are well-intended people in the Judiciary and in this body who do not intend to effectuate, continue systemic racism. It has more to do with the way implicit biases stack upon each other, the way that history seems to condense.

"In 2017, the Honolulu motion picture annual award ceremony named Out of State its best picture, which discussed this issue. There has been much discussion on best practices and research to the point.

"We support, through the payment of private prisons, organizations like GEO Group and CoreCivic, the private facilities that have been the primary beneficiaries of the Trump administration's jailing of children at the border. We hope that this practice will end.

"Just last week, in executive order, the Federal Government has ended its relationships with private prisons. We should do the same. As has New York, California, Texas, and other states.

"It currently costs \$78 per day to house a prisoner out of state. I would like, Mr. Speaker, for myself and other members to think of all the ways that the state is cutting to the bone and all the positions on the chopping block this year. The way we fund shareholder interest of private prison investors and we fund, essentially, children in cages.

"This bill will not take place immediately. It will not happen in the next year. It will happen in the next several years. In the passage of meaningful bail reform and sentencing reform as well as the smart prosecution of crime, which is already happening, as well as the inclusion of the oversight commission and data collected by the Supreme Court will be essential in this practice. Thank you, Mr. Speaker."

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support of my colleague from Kalihi. I'd like to have his words entered into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Tam rose to speak in support of the measure, stating:

"Mr. Speaker, same request," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1080, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE PHASEOUT OF PRIVATE CORRECTIONAL FACILITIES," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Okimoto and Ward voting aye with reservations, with Representative McDermott voting no, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 173) recommending that H.B. No. 1082, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1082, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Holt rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. Reservations, brief comment. With all due respect to my neighbor from Kalihi, if we don't build a new jail, we'll never get rid of OCCC, and I believe it's been in the works for a while. So, yes, thank you."

Representative Ganaden rose to speak in support of the measure, stating:

"Apologies that I do not know procedure in response or prospective rebuttal to my neighbor and the Representative from Kalihi. I am not in disagreement. In strong support. The eventual replacement of the Oahu Community Correctional Center will happen. It will happen probably sooner rather than later. However, it needs to be done with best practices, with the intention of supporting victims, with the knowledge that there is a disproportionate impact of criminal justice on certain communities, as well as with the inclusion of the Hawaii State justice oversight commission, which includes over 150 years of experience of state workers to talk about ways that we can include restorative justice practices, save the state funds. Thank you."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Perruso rose to speak in support of the measure, stating:

"Strong support."

Representative Har rose in support of the measure with reservations and asked that the remarks of Representative Holt be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1082, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CORRECTIONAL FACILITIES," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Har, Holt, Okimoto, Quinlan, and Tokioka voting aye with reservations, with Representatives McDermott and Ward voting no, and with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 174) recommending that H.B. No. 1110, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1110, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII CORRECTIONAL SYSTEM OVERSIGHT COMMISSION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Ohno being excused.

Representative Ohno, for the Committee on Corrections, Military, & Veterans, presented a report (Stand. Com. Rep. No. 175) recommending that H.B. No. 1389 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1389, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII CORRECTIONAL SYSTEM OVERSIGHT COMMISSION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Ohno being excused.

Representative Nakamura, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 176) recommending that H.B. No. 1311, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1311, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AFFORDABLE HOUSING," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Ohno being excused.

Representatives Nakamura and Tarnas, for the Committee on Housing and the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 177) recommending that H.B. No. 902, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Belatti moved that the report of the Committees be adopted, and that H.B. No. 902, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because it could subject a significant amount of ceded lands to extremely long-term, multigenerational leases. Native Hawaiian claims to 'ceded' lands must be recognized and protected against the broad leasing authority of the HHFDC. *Mahalo.*"

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ilagan rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ilagan's written remarks are as follows:

"I rise in opposition to House Bill 902, House Draft 1.

"This measure seeks to amend the definition of 'public lands,' removing certain procedural safeguards found in HRS Chapter 171 for public lands set aside from the governor or leased by other state departments or agencies to the Hawaii Housing Finance and Development Corporation (HHFDC).

"HB 902, HD 1 would allow ceded lands – which Native Hawaiians hold deep-rooted, intrinsic claims to – authorization to be 'leased or otherwise disposed of under HHFDC's broad leasing and disposition authorities,' as noted by the Office of Hawaiian Affairs (OHA).

"I would support a version of this measure that adopts the amendments offered by OHA which safeguard Native Hawaiian claims to ceded lands that may be subject to HHFDC's vague leasing authorities."

Representative Kapela rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Nakamura rose to speak in support of the measure, stating:

"In strong support and comments. Thank you, Mr. Speaker. Just wanted to state that HHFDC, right now, has to go to the DLNR each time they want to do something on public lands, which adds time and resources to get affordable housing built. This is their mission.

"People who have part Hawaiian or Native Hawaiians who do not qualify for DHHL lands, and there is an estimate of 200,000 part Hawaiians, have no other choice but to go, and who have low incomes, have no other choice but to work with HHFDC finance projects. So, you can put all of these lands in ceded lands and give it over to OHA, but these lands will stay empty unless we build affordable housing.

"And that's why I'm really proud that HHFDC has been working on Leialii in Lahaina, Maui to partner with DHHL for development of the Honokowai well. HHFDC is providing \$10 million of dwelling unit revolving fund and DHHL is funding any additional costs to build the well. They're going to split the water, and HHFDC sold village 1A and 1B at Leialii to DHHL.

"Furthermore, Mr. Speaker, HHFDC also sold improved lands to DHHL in various projects, including Laiopua in Kona, Hawaii, the Villages of Kapolei in Kapolei, Oahu, and Waiahole Valley on Oahu. I stand in strong support of efforts to give HHFDC the power to address the affordable housing need in the State of Hawaii."

Representative Eli rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Tarnas rose to speak in support of the measure, stating:

"Thank you. In strong support, and may I have the words of the Housing Chair adopted as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Tam rose to speak in support of the measure, stating:

"Same request," and the Chair "so ordered." (By reference only.)

Representative Har rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. May I please adopt the words of the Chair of Housing, and brief comments, please," and the Chair "so ordered." (By reference only.)

Representative Har continued to speak in support of the measure, stating:

"Mr. Speaker, this bill essentially gives HHFDC another tool in which to provide affordable housing for our local residents. At the end of the day, we do not have enough affordable housing in the State of Hawaii.

"The fact of the matter is, is that we have currently a study by UHERO shows that 11,000 people, because of the pandemic, are behind on their rental assistance payments. So, the fact of the matter is, is if we think that the homelessness population is not going to increase after the moratoriums are lifted, we're fooling ourselves. We need to do everything we can to support HHFDC so that they can expedite the production of affordable housing units in the State of Hawaii for our local residents. So, for these reasons, Mr. Speaker, I stand in strong support. Thank you."

Representative Hashimoto rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Strong support and I'd like to adopt the Housing Chair's comments as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Morikawa rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Strong support, and I'd like the words of the Representative from Kapolei and the Representative from District 14 as if they were my own. And also note that, as a part Hawaiian person who does not qualify for Hawaiian Home Lands, this is the opportunity for those people to get housing. And this is critical, we have asked OHA for some help in getting the database of all these people that may qualify for this. So, thank you, Mr. Speaker," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 902, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC LANDS," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives DeCoite, Gates, Okimoto, and Tokioka voting aye with reservations, with Representatives Eli, Ilagan, Kapela, and Perruso voting no, and with Representative Ohno being excused.

Representative Tarnas, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 178) recommending that H.B. No. 1144, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1144, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURE," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Ohno being excused.

Representative Tarnas, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 179) recommending that H.B. No. 320, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 320, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Ohno being excused.

Representative Tarnas, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 180) recommending that H.B. No. 821, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1124, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAIIAN HOMES COMMISSION ACT," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Okimoto voting aye with reservations, and with Representative Ohno being excused.

And I think it's also embarrassing if the public, again the guy in the street, the gal in the street, is gonna say, should the Judicial Selection Commission be guided by principles of merit in the selection of judicial nominations? Which recalls the opposite, what are these political cronies? No, they're not. They're adjudicated, judiciously and objectively. And this one is more embarrassing the way it goes out.

"Now, look, I'm not the guy in the street, but when I see feedback and I see wording like this, I think we can do a better job is the fact, Mr. Speaker. And the selection committee says they're already doing it. It ain't broke, so why fix it. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 340, entitled: "A BILL FOR AN ACT PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE STATE OF HAWAII TO REQUIRE THE JUDICIAL SELECTION COMMISSION TO BE GUIDED BY PRINCIPLES OF MERIT IN THE SELECTION OF JUDICIAL NOMINATIONS AND THE RETENTION OF JUDGES AND JUSTICES," passed Second Reading and was referred to the Committee on Finance, with Representative Okimoto voting aye with reservations, with Representative Ward voting no, and with Representative Ohno being excused.

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representative Tam rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations, and I hope that we can address some of the broadness in bill in the next committee."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. No. 643, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EMERGENCY MANAGEMENT," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Tam and Wildberger voting aye with reservations, with Representatives D.
