

## TWENTIETH DAY

Friday, February 19, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at 12:06 p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Bertrand Kobayashi, after which the Roll was called showing all members present, with Representatives Gates, Har, and LoPresti participating remotely via videoconference, and with the exception of Representatives Kong and Matayoshi, who were excused.

## REPORTS OF STANDING COMMITTEES

Representative Aquino, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 477) recommending that H.B. No. 1081, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1081, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SIDEWALKS," passed Second Reading and was referred to the Committee on Finance, with Representatives Har, Kong, and Matayoshi being excused.

Representative Kapela rose to speak in support of the measure, stating:

"I rise in strong support, Mr. Speaker. Teachers are the people on whom our children's and our society's futures depend. And while the DOE has talked about using federal funds to lessen learning loss endured by students

during the pandemic, nothing will make learning loss worse than losing qualified teachers in our student's classrooms. The DOE superintendent, Christina Kishimoto, has called for using \$53 million worth of federal funds to pay for private tutoring companies that are based outside of Hawaii. That's incredibly absurd.

"Three of the schools in my district are in the state's top five most severely impacted by the state's teacher shortage crisis. If we don't pass this measure to guarantee that federal funds are spent to keep quality and qualified teachers in our classrooms, then the teacher shortage crisis at schools in my community and across our state will continue to get much worse.

"HSTA has recently projected that even now, 700 teacher positions are on the chopping block. It has become incredibly clear that the DOE has no real plan to address Hawaii's teacher shortage crisis. Therefore, it is up to us as elected leaders and elected officials to ensure that our children are guided by professionals that they can trust to receive an excellent education.

"If the DOE needs money for tutoring, then I think that they should reduce the number of external contracts that it has for standardized testing, which recently totaled at least \$60 million. Teachers, however, should be the very first thing that the DOE and we, as legislators, defend. Thank you very much, Mr. Speaker."

If it's saying if you receive public assistance they're going to potentially come in your house and see if you have an old TV you haven't donated, maybe I'm misunderstanding this, but this seems like a weird overreach. So, I'm reservations now until I understand it further. Thank you."

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support and not so much in rebuttal but in response to the Representative from Ewa Beach. This bill would allow for e-waste, that accounts for tons of items currently going into landfills and into disposal, to be reused by members of the community. Oftentimes the devices that we use, they only require just a little bit of service, maybe a new hard drive, some more memory, to get them operable and used by students in our community. It will disproportionately help kids like the ones that I have the pleasure of representing. Thank you so much."

"In support. Just in advance of possibly other WRs, I just want to explain this bill. This poor bill, which I think was sadly misunderstood. On our electric bills, what this bill does, when you pay your electric bill, you pay a fee called the public benefits fee. The funds the work Hawaii Energy does for energy efficiency. A lot of what they do is provide rebates on major appliances like refrigerators, air conditioners, hot water heaters. And often when you go to the store to shop, you might not be aware this rebate that you're actually helping to fund is available.

"So, this bill would require, only for the appliances that are covered with rebates under the Hawaii Energy program and funded by the public benefits fee, that the availability of those rebates is displayed. That's the first part.

"The second part requires that the FTC-mandated little yellow tags when you buy a major appliance that indicates the cost to operate, those are all based on a mainland per kilowatt-hour cost average. And of course, Hawaii is an outlier in the cost of electricity and so the costs here are a lot higher. So, we're mandating, just for the appliances that are on the FTC registry, so not everything, and it's already a list that's already in existence, that those would be adjusted for Hawaii cost to operate. So that when consumers go shopping, they are aware of how much money they can save and they can make decisions appropriately.

"And the work to calculate the cost to operate would be one statewide average, not per county. That was a question that was mis-answered in the committee hearing, and that's specifically in the bill if anyone had read it. It would be one statewide average, and that calculation would be done by Hawaii Energy and the State Energy Office, and the template for the labels would also be designed by them. So it's very little work for any retailer to do, it's really about letting consumers know what their options are so they can make the best choices for themselves. So, thank you."

"Thank you, Mr. Speaker. Reservations and just a comment. ADC has partnerships in my district that the group is responsible for maintaining ditches, waterways, and because of that, it prevents extreme flooding for the town of Kekaha. So, this is very, very important for that town, and I just hope that these partnerships can continue if this bill should pass, and that's my main concern. Thank you, Mr. Speaker."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because I am not convinced that we need to get rid of the ADC. If the original purpose of the ADC was to take a lead role in converting the state's agriculture lands that were for producing pineapple and sugar to more economically viable farms, then that is still a worthwhile goal today. I am not certain that the Department of Agriculture can take on this additional new role since it already has a lot to do. Following a very negative audit, an agency typically tries to correct the problems highlighted in the report and I would like to hear more from ADC about their response to the audit. I look forward to hearing the discussion on this bill as it moves forward this session. *Mahalo.*"

Representative Perruso rose to speak in support of the measure, stating:

"In strong support with comments. So, I wanted to, in brief response to the Representative from Kauai, this bill does call for the repeal of ADC and to bring the activity, the work of ADC around land management and irrigation projects under the Department of Agriculture. And it does so because we have received a very scathing audit report as well as an independently produced report from UHERO, and both reports came to the same conclusions.

"So, Mr. Speaker, the gross mismanagement of public lands and public monies by this attached agency has been going on for 27 years and it has led to a serious erosion of public confidence. So, I am calling for a repeal of ADC, because when we look at its history, it was created in 1994, the Agribusiness Development Corporation, and it was provided with really important exemptions.

"So, the purpose of the law, of the agency, in fact, was to help us transition away from sugar and plantation lands and towards diversified sustainable agriculture done by small farmers. And when it was first created, it was given broad powers to buy, own, and develop these lands. So, it's granted exemptions from public land trust's regulation, from Public Utilities Commission's regulations, and also from civil service law. But with these powers, not only was it unable to affect the kind of work that it was meant to do, but it also led to serious questions about transparency in our work in this public-private partnership.

"So, just for the record, 1998 was the first time that repeal was called for, and that was on the basis of work that we asked for. We asked the LRB to

conduct a report, and on the basis of that report, House Bill 3625 called for the repeal of ADC and its incorporation into a newly reorganized Department of Education. In 2006 and 2007, we went through the process. LRB did the same work again, made recommendations, seven recommendations, none of them were acted upon.

"So, here we are again, under the current leadership we have been asking for years for an audit. We finally receive the audit. The results are scandalous, I've never read an audit report like that. And I think that it's time for us to hold this agency accountable for the purposes of improving public confidence in government. Thank you, Mr. Speaker."

Representative McDermott rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I'd just like to commend the introducer and of course the previous speaker for her courage in introducing this bill. I wouldn't say the report was scandalous, more like comical, it was so bad. And if nothing else, this is a shot across the bow to tell them to get their act together. So, I applaud the introducer of the bill. Thank you."

Representative Kapela rose to speak in support of the measure, stating:

"In strong support and I would like the words of the Representative from Wahiawa inserted into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Ganaden rose to speak in support of the measure, stating:

"Strong support, same request," and the Chair "so ordered." (By reference only.)

Representative Marten rose to speak in support of the measure, stating:

"I'm in support with comments. I just wanted to say that I hope that with the transition to the Department of Agriculture, I hope that the powers that allow ADC to do small leases with small farmers will also be moving with them because there are initiatives currently underway that are very important to my district. Thank you."

Representative Har rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition and very brief comments, Mr. Speaker. I do appreciate the words of the introducer and some of the other members who are in support of this measure. But that said, the whole point of an audit is to find out what are the issues with a particular agency or department. And now that we know, it's my understanding they're working towards addressing those issues. You just don't throw away or repeal a department that actually does a lot of great things that the Department of Agriculture cannot do.

"The whole point of setting up many of these independent but attached agencies, like the Hawaii Strategic Development Corporation or even Agribusiness Development Corporation, was to give them the latitude to do things that other departments were unable to do because of government bureaucracy. So, to just throw the baby out with the bath water without even giving them a chance to address the audit is just a shame in my opinion. So accordingly, Mr. Speaker, I'm in opposition. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, with reservations and with a comment that I guess meshes with what has been previously said. The fact that we're handing it over to government from quasi-government, if the private sector can't do it, I would like to see what happens in the years ahead when the government, now the Department of Agriculture, is posed and poised to do this. This will be a real test, of which I doubt is going to be successful. Thank you, Mr. Speaker."

Representative LoPresti rose to speak in support of the measure, stating:

"Strong support with comments. I'd simply like the words of the Representative from Wahiawa entered into the record as if they were my own," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1271, entitled: "A BILL FOR AN ACT RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION," passed Second Reading and was referred to the

"It's also a huge barrier to new candidates, because they come in unaware that they have to file them in the first place. When this was initially initiated a couple years back, there were brand new candidates who ended up getting fined into the fives, tens of thousands of dollars because they were unaware of the reporting.

"In addition to that, the Campaign Spending Commission does not actually do their due diligence in finding people who violate them. They instead rely on you to self-report. So, it rewards people who do not report their electioneering communications and punishes those who report that they were a day or two late.

"I've yet to find a single valid public use for the electioneering communications. All it does is tell you what people already know. Did you know that this campaign ran an ad in the newspaper, and they paid for it? It doesn't make any sense. So, I hope we go further, this is a good step.

"But in addition to this, if you really wanted to make this a useful form of public disclosure, you would require very large multimillion-dollar campaigns to disclose every single expenditure that is made by consultants on their behalf. Because what happens is, if you're a relatively minor candidate like most of us, you spend a few thousand dollars here and there on ads or on mailers or on newspaper ads. But if you're running a multimillion-dollar campaign, you just say I spent \$100,000 at so-and-so consultants and they do stuff on my behalf.

"It serves no purpose and I hope we go much further and eliminate them altogether. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. "In strong support."

Representative Ohno rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. This measure would sunset the motor vehicle weight tax that the state provides to the well deserving women and men of the National Guard and in the military. It's a measure that I would have never hoped to support, but the gravity of COVID-19's impacts on Hawaii's people weighs on me.

"It's a reality that this year, teachers may be furloughed, businesses may face hiked tax rates, and services for children and families may disappear. Together, we face this very unforgiving budget shortfall and I feel all options must be on the table. This is my painful contribution but contribution nonetheless to address this once-in-a-lifetime challenge that faces all of us. Thank you, Mr. Speaker."

Representative Tam rose to speak in support of the measure, stating:

"In support with a brief comment. Before I begin, I just want to say I have the utmost respect for our men and women serving this country in uniform, and because of that I believe that they should have the privilege of driving on some of the best roads that we can provide, and this does just that. We have to ensure that the Department of Transportation is publicly funded well.

"I remember a few years back where we had talk about raising the gas tax. And if we continue on this path where our infrastructure continues to crumble, we may have to revisit the gas tax again, and the last time I checked, no one is exempt from paying the gas tax. So, for these reasons, I'm in support."

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support, requesting the Representative from Waikiki's comments to be introduced as my own," and the Chair "so ordered." (By reference only.)

Representative Sayama rose to speak in support of the measure, stating:

"In support, Mr. Speaker."

Representative Ward rose to respond, stating:

"Mr. Speaker, second time for my no vote. As a Vietnam veteran, I've got to say something for the military. Not that we're going to wave the flag, but to remember that there's a number of things that doesn't happen after you get out of the military. Settling back in, getting a job, getting a vehicle. Getting a *manini*, if you will, break, if you will, \$200, \$300 for a year.

"This is a gesture of support for our military. It is not something that's going to build the roads, as the young man said, that we're going to have the best roads. We've got the worst roads, in the State of Hawaii, and to say that this is going to help it out versus another thing of pushing back the veterans, I think for those reasons, there's a few veterans here on the floor that would agree that this is a gesture that we gave not only to Vietnam veterans, Gulf War veterans, and the others. But to take it back now I think is untimely and very, quite frankly, unhelpful to what otherwise is the cause that has been given. Thank you."

Representative Tam rose to respond, stating:

"Thank you, Mr. Speaker. Again, in strong support. I want to clarify what the Representative from Hawaii Kai said. Veterans are not exempt from the vehicle weight tax."

Representative Perruso rose to respond, stating:

"Rising again in strong support with some explanation. When I first started running for office, the issue that confronted me when I was talking to people on the doors was exactly this issue. The lack of fairness in our taxation system, especially with respect to this particular exemption. So, I am grateful for this measure and I stand in strong support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 290, HD 1, entitled: "A BILL FOR AN ACT RELATING TO VEHICLE WEIGHT TAXES," passed Second Reading and was referred to the Committee on Finance, with Representatives Branco, DeCoite, and Matsumoto voting aye with reservations, with Representatives McDermott, Okimoto, Tokioka, and Ward voting no, and with Representatives Har, Kong, and Matayoshi being excused.

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and H.B. Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1286, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm voting no again on this bill and I'd like to make a brief comment. Disaster response 101 dictates that local on-the-ground decision makers are able to do just that, pivot, respond, and make decisions that best effect their area.

"I think it's very important for the counties to retain their autonomy. And I think if we're going to fix one thing with the Safe Travels program, it be people that actually got a test 72 hours before their departure but have not received their results be allowed to come in and quarantine only until their results are received, instead of black-and-whiteing the decision and making them wait for the entire 10-day quarantine.

"Surveys from HTA show that 20% of the arrivals are struggling with the Safe Travels program. That's a B-minus, that isn't that bad. And if we could just fix the component that requires a 10-day quarantine of everyone, even people that didn't happen to receive their test results prior to their departure and have it day of arrival or the next day of arrival, that would go a long way to fix the challenges with this system and still allow our counties to retain their autonomy. Thank you."

Representative Tokioka rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No vote and I'd like to ask that the words of the Representative from Kihei be inserted into the Journal as if they were my own. And I'd also like to add and insert the comments that I made on the floor on February 12th regarding this bill. Thank you very much," and the Chair "so ordered." (By reference only.)

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because I do not believe Hawaii needs a one-size-fits-all approach to rebuilding our economy. Each county follows the state's guidelines and requests the governor's approval before making any deviations from his proclamations. Although there may be some confusion and the rules may be cumbersome or inconvenient, our top priority is keeping our people safe. As we move forward with vaccinating our residents, we need to exercise caution as we reopen our economy. *Mahalo.*"

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Kapela rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Nakamura rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, brief comment, please. Mr. Speaker, the irony of this bill is that Kauai is doing it right. They got the lowest cases, they got the lowest death rate on a proportional basis. What they're doing is really good, and when the neighbor islanders stand up and say, hey, you know, we really need to get over this, it's a shame.

"And the other thing that's missing in this, and I've mentioned it numerous times on this floor and it's probably a broken record, we need fast and cheap testing, not just the vaccinations. And that's our own first pharmaceutical potentially with Oceanit, it's down the street in downtown Honolulu. Patrick Sullivan has you spit in a cup, 10 minutes, \$20, and until we get that, Mr. Speaker, we're going to have all of the 72-hour chaos of which she said, I think it's more than 20% who think this is really bad. To get my daughter here for Christmas was just a headache, and getting back from a conference was a headache. And we're supposed to know all this, as representatives.

"Having said that, Mr. Speaker, we've got to do a better job. And this one kind of says, okay, one-size-fits-all, but one size is not going to be the cure all. And that's the issue of which, if Kauai is doing a better job, *e komo mai*, let's go for it. This doesn't allow that, and for those reasons, I have very strong reservations. Thank you."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I stand in support, however I do have reservations on the measure, if I may. I wouldn't speak on second reading, but I've been getting flayed by my constituents on this measure. Nowhere have you seen the divisiveness of it come up in an area where you have a lot of concerns of small community of what COVID and the variants can do, but in addition you have the highest unemployment in the nation because the visitor industry has yet to recover.

"The bill is a work in progress, Mr. Speaker. I joined on it because of what I thought was the counties starting to enter an area that before February of last year that they weren't involved in. In the airports, in the harbors, in other areas. They weren't doing inspections back then. They weren't doing their own forms. They weren't doing different things, different rules. When I signed on, one of the proposed rules coming out of the county was to allow county workers to inspect people's cell phones for their privacy settings. Things that add a lot of confusion and actually undermine public safety.

"And so, however, this is a conversation, there is language in this bill that is troubling. Language that I think goes beyond your normal natural order, if you will, of county preemption and state preemption. And that's what worries a lot of our citizens right there, that it may go too far.

"However, this situation with COVID is fluid and changes every day. One of the things I've discussed this morning with my community is the Governor's idea to exempt all vaccinated people from all testing whatsoever. This measure could provide for a framework of mandatory testing so that the Governor couldn't move ahead with such a move, which concerns a lot of people.

"Mr. Speaker, noting all of these, I wish, and I hope other committees will have these discussions, there's an effective date, I stand with reservations, but they're serious reservations and I hope they'll be considered moving on. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1286, HD 2, entitled: "A BILL FOR AN ACT RELATING TO TRAVEL," was referred to the Committee on Finance, with Representatives DeCoite, McKelvey, Okimoto, and Ward voting aye with reservations, with Representatives Kapela, Nakamura, Perruso, Tokioka, and Wildberger voting no, and with Representatives Har, Kong, and Matayoshi being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 621) recommending that H.B. No. 643, HD 1, as amended in HD 2, be referred to the Committee on Finance.

I'm concerned that the definition of essential workers is entirely too broad and that neighbor islands are not offered enough protection with this bill. We want to protect our essential workers that are sort of sitting ducks in grocery stores and places of public enterprise. But when you've got people who are called essential workers and doing a variety of tasks, flying interisland on a regular basis, we've had issues with community spread and seeding a virus. And with the variants coming, I feel like that we need to narrow the definition of essential worker. Thank you."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"Thank you, Mr. Speaker. With reservations and a few comments. First, I'd like to start off just by thanking all of the nurses and APRNs for the work that they do, especially during the pandemic. They are an important part of the healthcare profession and my reservations do not stand from a belief that they are not capable of providing excellent health care or do not play an integral role in our healthcare community. I also appreciate the work of the HHH and CPC Committee Chairs who have done work on this bill and the other APRN bills to address inequities within our healthcare system.

"However, my reservations for this bill as well as other APRN-related bills that I have voted with reservations on stem from the way that the

Legislature is addressing policy related to the APRN profession. Since 2009, over the past 12 years, Hawaii's Legislature has passed 22 laws related to the scope of practice for APRNs. And in looking at information provided by the Hawaii State Center for Nursing, there are actually more than 22 laws that have passed related to the practice and expansion of this profession. The CPC Committee recently heard four bills related to expanding the scope of APRN practice in a variety of ways. There is also a Senate bill this session that looks to expand the scope of APRN practice here in Hawaii.

"I am surprised that there have been so many laws passed to expand or clarify the scope of practice for this one profession. I am concerned about the piecemeal fashion of these multiple pieces of legislation. As the healthcare needs of our communities continue to grow, I believe that it's important to look at legislation in a holistic manner. When we look at legislation to expand the scope of practice for a profession in an isolated manner, we miss seeing the bigger picture of how all these singular bills connect to one another and how they can impact each other in our communities. I can understand that as needs change, sometimes a handful of bills are necessary to address these issues. However, over 22 laws and at least four bills this session seems like quite a bit to address the needs of one profession.

"I'd like to see us have conversations, including with multiple stakeholders, to discuss what the role of APRNs and other healthcare professionals should be in addressing the many healthcare concerns we have in our communities. At some point, without having these discussions, the distinction between the different types of healthcare professionals, including physicians, becomes blurred. I believe we will continue to see piecemeal legislation in future sessions looking to expand the scope of practice for APRNs and other healthcare professionals without having these conversations. And I don't believe that that's in the best interest of our communities. Thank you for letting me share my reservations."

Representative Marten rose to speak in support of the measure, stating:

"I would like to comment in strong support. I just wanted to reflect on the comments from the Representative from Kaneohe and say that this bill and the intent of expanding the scope of services, which would be a benefit to neighbor island women and their families, is not about the healthcare providers, it is about the patients."

Representative Ward rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I have a no vote and a brief comment, not a rebuttal but an explanation. Why are we picking on the APRNs or designating so many things over the last few years as to what they do? The answer is very simple. We have a shortage of physicians. If the physician is not there, we gotta give it to the nurses. The APRNs are there.

"Why do we have a shortage of physicians? Well, the cost of living, the cost of housing, and Mr. Speaker, the buck comes back to us. What have we done about that? Even though last year when we opened the session we were going to fix it, we got COVID, now we gotta get it back on the front burner and get cost of housing, get the cost of living down, because all of these things are going to keep multiplying and APRNs are probably going to even be revisited even more in the future. Thank you, Mr. Speaker."

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support with a brief comment. This bill offers neighbor island residents access to health care that Oahu residents take for granted. This is about equity in healthcare access for neighbor islands. And if we didn't have a shortage of doctors, then we wouldn't have to put all of these functions into nursing capacity, but we simply don't have the access to doctors, and we need that. These are constitutionally confirmed rights for women, and we don't, right now, have that access on Kauai, in the County of Maui, or on the Big Island. Thank you."

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kapela rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support and I would like the words of the Representatives from both Maui and Waimanalo inserted into the Journal as if they were my own. We need access, especially on the neighbor islands, and we have to make sure that this building is giving young women that opportunity to choose what they do with their bodies," and the Chair "so ordered." (By reference only.)

Representative DeCoite rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support and I'd like to ask for the words of the Representative from Kihei be entered into the Journal as if they were my own. And to add on that, in the most isolated areas of my district and limited travel to come back to Oahu and to have those services needed, I think this is highly needed in our area. So, thank you, Mr. Speaker," and the Chair "so ordered." (By reference only.)

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B.
