"From a cost point of view, government cost point of view, if we take away the option for private prisons, we're going to really up the cost of government. We almost double, \$150 a day to have a prisoner here, I think it's \$70 or \$80 to have it on the mainland. That should be an option for government to be able to choose given how much money is available.

"But lastly and most importantly, the word is that some prisoners from Hawaii, in fact a number of them, will choose to go to a mainland prison because they have skill training. They get a skill when they get out. Here we don't have that skill training or vocational training. We put them out on the street, and many end up homeless. So, for those reasons, person who go to the mainland come back with a skill, and I think that should be an option that we allow people to have. For those reasons, Mr. Speaker, a no vote."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Sayama rose to speak in support of the measure, stating:

"In support, Mr. Speaker. While I acknowledge the state's need to house our inmates in out-of-state private prisons, I feel like the state has a moral responsibility to house our inmates in state, as the Representative from Hawaii Kai mentioned, that recidivism rates are a contribution to the state's expenses and when we house our inmates out-of-state, we only increase the recidivism rates for these inmates.

"I also believe that the state should not see the private prison institutions as a long-term solution, as only a temporary solution to address the issues we have with our own criminal justice reform right at home. Thank you, Mr. Speaker."

Representative Har rose in support of the measure with reservations and asked that the remarks of Representative Ward be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

"I rise in support of this measure. I want to take this opportunity to share some statistics facing our Native Hawaiian population that is incarcerated. According to the Hawaii Criminal Justice Data Center Report, Native Hawaiians make up 39% of the incarcerated population, compared to 25% of the state population. Forty-four percent of incarcerated women in Hawaii are Native Hawaiian, compared to Native Hawaiian women making up 19.8% of the general population. These statistics leave me with many questions. And these questions are, why is it this way, what are we doing as a body to fix this, and how do we decriminalize someone who is consistently called a criminal? *Mahalo*."

Representative Sayama rose to speak in support of the measure, stating:

"Once again in support. As I mentioned earlier, I strongly believe that Hawaii should phase out our private prison systems. We should look for more long-term sustainable criminal justice reform back in our state. As was mentioned in the testimony from the Department of Public Safety, our jails and prisons are significantly under resourced and dilapidated, making it very dangerous for not only the inmates but also the staff that work there. So, I hope going forward that this measure will put a spotlight and address the long-term, our needs for criminal justice reform at home. Thank you."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, no vote with the same comments from the earlier bill regarding correctional facilities."

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. A young man from Kihei named Bronson Nunuha was brutally murdered at Saguaro Correctional Center, a private for-profit prison in Arizona, while serving five years for burglary. Hawaii, which pays Corrections Corporations of America millions of dollars annually to house its prisoners, has known for years that CCA-run facilities have struggles with gang violence. A 2001 Hawaii report on another Arizona facility managed by the same private for-profit company wrote that one gang runs the facility.

"These private for-profit prisons are not leading to a reduction in crime, the majority of Hawaii's incarcerated males are locked up far from home in Saguaro, far away from their families and support networks, making the ultimate goal of rehabilitation even more difficult. We're creating a diaspora.

"Mahalo to my colleagues and especially the corrections chair and vice chair for moving this bill forward. We must break free from our contracts with private prisons. We must start recognizing that our prisoners are our kuleana, and we need to start embracing restorative justice practices. Mahalo."

Representative Tam rose in support of the measure and asked that the remarks of Representatives Branco, Sayama, and Wildberger be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)
