

FORTY-SECOND DAY

Monday, April 5, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at noon, with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Gregg Takayama, after which the Roll was called showing all members present, with Representative Har participating remotely via videoconference, and with the exception of Representatives LoPresti and Woodson, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fortieth and Forty-First Day was deferred.

GOVERNOR'S MESSAGES

The following message from the Governor (Gov. Msg. No. 6) was received and announced by the Clerk and was placed on file:

Gov. Msg. No. 6, dated April 1, 2021, transmitting proposed changes to the Fiscal Biennium 2021-23 Executive Budget due to the changes to the State's fiscal situation and the requirements of the American Rescue Plan Act of 2021.

Representative Luke rose, stating:

"Point of information, Mr. Speaker. Thank you, just stating on a point of information. Usually we don't react to the Governor's message, but I just wanted to alert the members that one of the messages, and we have to vet this a little bit more, as people on Finance Committee know, the information contained in this Governor's message is in error."

"The amount that is requested in general assistance as reflected in this message is not consistent with what was provided to us with Department of Human Services. So, what we will be doing is requesting the Governor's Office and Budget and Finance to reevaluate the messages to make sure that it's consistent with their departments. I wanted to just alert the members before they get into the details of this message, since we have found an error. Thank you."

SENATE COMMUNICATIONS

Combat Team. The 442nd was composed of *nisei* men from Hawaii and mainland internment camps who trained in Shelby, Mississippi.

"In their two years of service, the 442 earned numerous awards, including seven Presidential Unit Citations and 21 Medals of Honor. So, let us reflect how the struggle of Asians and Asian Americans have persisted throughout history of our country, but more importantly we must recognize how those who have come before us have persisted in the face of fear and discrimination, and we ourselves must persist and go for broke in our service and leadership to our communities. Thank you, Mr. Speaker."
