The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at 12:02 p.m., with Speaker Saiki presiding.

The invocation was delivered by Representative Lauren Matsumoto, after which the Roll was called showing all members present, with Representative Har participating remotely via videoconference, and with the exception of Representatives Ohno and Ward, who were excused.
