No. 55, SD 1, HD 1, entitled: "SENATE CONCURRENT RESOLUTION URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ADOPT ADMINISTRATIVE RULES TO STREAMLINE THE PROCESS FOR ALLOWING TRADITIONAL HAWAIIAN FARMING SYSTEMS ON CONSERVATION LANDS," was adopted, with Representatives DeCoite, Hashem, McDermott, Ohno, and Tokioka being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1880) recommending that S.C.R. No. 207 be adopted.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.C.R. No. 207, entitled: "SENATE CONCURRENT RESOLUTION SUBMITTING TO THE LEGISLATURE OF THE STATE OF HAWAII FOR REVIEW AND APPROVAL OF ACTION TAKEN BY THE BOARD OF LAND AND NATURAL RESOURCES ON A LAND EXCHANGE BETWEEN THE STATE OF HAWAII AND PARKER LAND TRUST," was adopted, with Representatives DeCoite, Hashem, McDermott, Ohno, and Tokioka being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1881) recommending that S.C.R. No. 220, SD 1 be adopted.

Representative Belatti moved that the report of the Committee be adopted, and that S.C.R. No. 220, SD 1 be adopted, seconded by Representative Morikawa.

Representative Aquino rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Aquino's written remarks are as follows:

"Thank you, Mr. Speaker. In support of SCR 220.

"This is a meaningful resolution that acknowledges the contributions of Filipino Americans to the island fabric of Hawaii and our island way of life. It is a friendly reminder of our long history and the possibilities of re-energizing our sister city relationships. This resolution further requests the continuation of working together to further strengthen ties between Hawaii and the Republic of the Philippines through the Philippine Consulate General's office in Honolulu. I'm hopeful that Hawaii and other U.S. states with sizable populations of Filipinos will continue to make significant contributions to the American experience despite what we are seeing today involving all Asian-Americans. *Mahalo*."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.C.R. No. 220, SD 1, entitled: "SENATE CONCURRENT RESOLUTION RECOGNIZING THE SEVENTY-FIFTH ANNIVERSARY OF DIPLOMATIC RELATIONS BETWEEN THE UNITED STATES OF AMERICA AND THE REPUBLIC OF THE PHILIPPINES," was adopted, with Representatives DeCoite, Hashem, McDermott, Ohno, and Tokioka being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1882) recommending that S.C.R. No. 235, SD 1 be adopted.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 1883) recommending that S.C.R. No. 25, SD 1 be adopted.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.C.R. No. 25, SD 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC SAFETY TO ALLOW FAITH PODS BASED ON KAPU ALOHA TO BE ESTABLISHED WITHIN EACH CORRECTIONAL CENTER," was adopted, with Representatives DeCoite, Hashem, McDermott, Ohno, and Tokioka being excused.
