My problem with the bill is that this will inextricably exacerbate a lack of school infrastructure for those people as well as for especially people on the west side of Oahu where I represent.

"We still have the largest high school in the state that still is lacking massive infrastructure. We still need a new, even larger, high school for that community. And I just feel that this is trying to help one constituency by taking away from another one that needs help, and I just don't like that way of problem solving. And so, I have to be in opposition for the kids. Thanks."

### ANNOUNCEMENTS

Representative Lowen: "Thank you, Mr. Speaker. I just wanted to take a minute on the floor to recognize that today is the 51st anniversary of Earth Day, which was founded in 1970. Last year was the 50th, and many events were planned to celebrate the 50th but had to be cancelled because of COVID, so I didn't want to miss the opportunity this year.

"The initial Earth Day marked a moment when many Americans recognized that we must start thinking about doing things differently and not operating our economy in such a way that we cause continual cumulative damage to the environment. The initial Earth Day and environmental movement in the US led to the creation of the EPA, the Clean Air and Clean Water Acts, the Endangered Species Act, and OSHA. And yet despite these accomplishments now today, we are living with the consequences of having failed to successfully meet those challenges that were recognized 51 years ago.

"We still grapple with how to reduce emissions from transportation and power plants, pollution and run off that threaten coral reefs, growing landfills, and plastic pollution that has made its way into the air we breathe, the food we eat, and the water we drink, and an alarming loss of biodiversity as wilderness and wildlife disappear. And unfortunately, we don't have 51 more years left to solve these problems. If we cannot change course, we are headed rapidly toward an Earth that will be radically changed and potentially uninhabitable. This could happen in our lifetime and it will happen in the lifetime of our children if we cannot take collective action in time.

"So, as we wrap up this legislative session, I'm proud of what we have all accomplished together, including some great bills that look like they will pass relating to the climate crisis, clean energy, clean transportation, sea level rise, and conservation. But we also have so much more work to do if we are to meet the huge challenges ahead. So, today on the 51st Earth Day, let us recommit together to our *kuleana*, to work together to be the leaders that future generations and the planet need us to be."

Representative Ward: "Thank you, Mr. Speaker. It's not only Earth Day, it's also the Peace Corps' birthday. This is the 60th anniversary from President Kennedy's founding of the Peace Corps in 1961 with a quarter million of Americans who have served overseas. In Hawaii, there's been 1,600, Mr. Speaker. And you know our colleague Richard Creagan was a Peace Corps volunteer, our colleague former Representative Jim Shon, and yours truly served in the Peace Corps. In fact, people wonder why you're so independent, well if you live two years in the jungles of Borneo, you get to be a little bit independent minded.

"But the bottom line is this, Mr. Speaker. This is Peace Corps Week, and I know some of you have had staffers who wanted to join the Peace Corps, you've come to talk to me. I just want to open that up again as anyone interested in joining the Peace Corps, this is the time to do it, this is the place in the nation. And if we want a better world, we've got to be able to do the economic and social and otherwise development that the Peace Corps has done. So, I'm very proud to announce this is the Peace Corps Week, and anyone who is interested in doing that, I would be more than glad to help to give information. Thank you, Mr. Speaker."

Representative Tokioka: "Thank you, Mr. Speaker. Not an announcement but a point of clarification. As the Majority Leader was going through the different bills and resos, and this is something new on the action sheets, I'm assuming that these are not big changes because on the yellow sheets that we used to get we can at least follow and find out which bills have issues that we may have to vote with reservations or no votes, and this process is very hard to allow us to do that. So, I'm not sure if we're going to do the same thing tomorrow, but hopefully we can get more clarifications because I'm not sure if everybody knew exactly what resos and bills we were voting on and what information was in there that we didn't get on a sheet."

Vice Speaker Mizuno: "Excellent point. I think that's why the leadership asked that we defer it for one legislative day, the concurrent resolutions, but we'll do our best to keep everyone updated on the measures before us."
