The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at noon, with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Della Au Belatti, after which the Roll was called showing all members present, with Representatives Har, Kitagawa, LoPresti, Matayoshi, Matsumoto, Perruso, Quinlan, Ward, and Wildberger participating remotely via videoconference, and with the exception of Representatives Cullen, Hashem, and McDermott, who were excused.
