The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 12:02 p.m., with Vice Speaker Mizuno presiding.

They are released back into society with very little skills or capacity, despite years of incarceration and missed opportunities.

"We were also surprised this year by the lobbying efforts of the Women's Prison Project, a coalition that spans multiple sectors and is across party lines. I was pleasantly surprised in how much I agreed with former Republican Governor Linda Lingle that we need to effectuate significant criminal justice change here and across America. Just years ago, versions of the corrections committee was all about enhancing sentencing. Now, the conversation has changed to reduce incarceration, to rehabilitate community members, and to support victims.

"If we pass this and the other measures that are before us, about half a dozen of them, we will be making a significant change here in the State of Hawaii. We are all very close to the justice system. Addiction, poor decisions can affect all of us or all of our families. This measure shows our shared humanity across multiple sectors, across party lines. Thank you so much. I think that we should pass it and pass the other bills that are associated with it for future generations. Thank you so much."

No. 2583, SD 2, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC LANDS," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Kong voting aye with reservations, with Representatives Ganaden, Kapela, and Perruso voting no, and with Representatives Branco, Ilagan, McKelvey, and Ohno being excused.

Representatives Nakamura and Tarnas, for the Committee on Housing and the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1164-22) recommending that S.B. No. 3261, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

The motion was put to vote by the Chair and carried, and the report of the Committees was adopted and S.B. No. 3261, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOUSING," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Kapela, Kong, and Perruso voting aye with reservations, and with Representatives Branco, Ilagan, McKelvey, and Ohno being excused.
