

FORTY-SECOND DAY

Friday, April 1, 2022

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at noon, with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Roy M. Takumi, after which the Roll was called showing all members present with the exception of Representatives Gates, McKelvey, Ohno, Okimoto, Quinlan, and Woodson, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-First Day was deferred.

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

No. 139, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS TO CONDUCT AN ANALYSIS REGARDING THE SCOPES OF PRACTICE FOR ADVANCED PRACTICE REGISTERED NURSES AND PHYSICIAN ASSISTANTS," was adopted, with Representative Nakamura voting aye with reservations, and with Representatives Gates, McKelvey, Ohno, Okimoto, and Quinlan being excused.
