Wednesday, April 6, 2022

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 12:05 p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Patrick Pihana Branco, after which the Roll was called showing all members present, with Representative Wildberger participating remotely via videoconference, and with the exception of Representatives Costales and D. Kobayashi, who were excused.
