

**NINTH DAY**

**Wednesday, February 1, 2023**

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 12:03 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Diamond Garcia, after which the Roll was called showing all members present with the exception of Representatives Amato, Nakashima, and Sayama, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Eighth Day was deferred.

Representative Matayoshi, for the Committee on Labor & Government Operations, presented a report (Stand. Com. Rep. No. 5) recommending that H.B. No. 565, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Nakamura moved that the report of the Committee be adopted, and that H.B. No. 565, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support of this bill. I'm speaking on second reading because this is a money saver. Not a money maker, but a money saver. And secondly, if it's introduced by the chair of Finance, you know it's going to save us money. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 565, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATE SELF-INSURANCE AGAINST PROPERTY AND CASUALTY RISKS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Amato, Nakashima, and Sayama being excused.
