Representative Garcia rose to speak in opposition to the measure, stating:

"In opposition, Mr. Speaker. This bill, HB 132, proposes to remove hand counting paper ballots in the audit process. For audit purposes and to ensure that there is integrity in the election process, it's essential that we preserve paper ballots in the audit process. And I do want to thank the Kaua'i County Council for passing resolution 23-21 opposing this bill, because it is a bad bill. And right now, the Legislature has such a low ratings of approval and it's stuff like this which adds to that and why there is so much distrust from the public. So, no vote. Thank you."

Representative Pierick rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 132, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Alcos and Matsumoto voting aye with reservations, with Representatives Garcia, Pierick, and Ward voting no, and with Representative Holt being excused.

Representative Tarnas, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 782) recommending that H.B. No. 141, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.
