Monday, March 13, 2023

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 12:01 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Lauren Matsumoto, after which the Roll was called showing all members present with the exception of Representatives Amato and Perruso, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Eighth Day was deferred.

ORDER OF THE DAY

REPORTS OF STANDING COMMITTEES

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1220) recommending that H.B. No. 133, as amended in HD 1, pass Third Reading.

By unanimous consent, consideration of Stand. Com. Rep. No. 1220 on H.B. No. 133, HD 1, was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawai'i, printed copies of H.B. No. 133, HD 1, were made available to the Members of the House.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1221) recommending that H.B. No. 382, as amended in HD 1, pass Third Reading.

By unanimous consent, consideration of Stand. Com. Rep. No. 1221 on H.B. No. 382, HD 1, was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawai'i, printed copies of H.B. No. 382, HD 1, were made available to the Members of the House.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1222) recommending that H.B. No. 300, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative Nakamura, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 300, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Amato, Holt, Ichiyama, Lowen, and Perruso being excused.

SUSPENSION OF RULES

On motion by Representative Morikawa, seconded by Representative Garcia and carried, the rules were suspended for the purpose of considering a certain House Bill for Final Reading by consent calendar. (Representatives Amato, Holt, Ichiyama, Lowen, and Perruso were excused.)

FINAL READING

H.B. No. 1514, HD 1, SD 1:

Representative Nakamura moved that H.B. No. 1514, HD 1, SD 1 pass Final Reading, seconded by Representative Morikawa.

Representative Pierick rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No. I do believe we should fund the Legislative Reference Bureau, the auditor, the Ethics Commission. But I believe our salary is too high, \$72,000 for a four-month job is I don't think a smart appropriation of our tax dollars. I believe we should mirror Abilene, TX, where their mayor is a volunteer position. I propose we are all volunteer positions, that we not use tax dollars for this measure."

Representative Marten rose to speak in support of the measure, stating:

"I rise in support. I just wanted to note that it is not a four-month job, we should be serving our district year-round. There's a lot of projects and needs throughout the year, it's not just bills. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 1514, HD 1, SD 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU, THE OMBUDSMAN, AND THE ETHICS COMMISSION," passed Final Reading by a vote of 45 ayes to 1 no, with Representative Pierick voting no, and with Representatives Amato, Holt, Ichiyama, Lowen, and Perruso being excused.

At 12:30 p.m., the Chair noted that the following bill passed Final Reading:
