THIRTIETH DAY

Tuesday, March 14, 2023

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 12:04 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative John M. Mizuno, after which the Roll was called showing all members present with the exception of Representatives Kobayashi and Perruso, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Ninth Day was deferred.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS (FLOOR PRESENTATIONS)

The following resolution (H.R. No. 214) was announced by the Clerk and the following action taken:

Representative Mizuno, for the Committee on Human Services, presented two reports:

(Stand. Com. Rep. No. 1223) recommending that H.R. No. 6, as amended in HD 1, be referred to the Committee on Consumer Protection & Commerce; and

(Stand. Com. Rep. No. 1224) recommending that H.C.R. No. 7, as amended in HD 1, be referred to the Committee on Consumer Protection & Commerce.

Representative Nakamura moved that the reports of the Committee be adopted, and that H.R. No. 6, HD 1 and H.C.R. No. 7, HD 1 be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Ward rose to speak in support of both measures, stating:

"Mr. Speaker, I rise in strong support. This is a very important bill, particularly for the two main issues that I have in this session. Number one, Hawaiian issues, and number two, ALICE issues. According to the governor's whiteboard, there are 450,000-plus members in Medicaid. So, this reso is a way of expanding or at least keeping the ALICE families up to speed with their health, *et cetera*. This is a very good reso to remind us of that. Thank you."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R.
