So, he was from Kentucky, and if they had full campaign funding for Kentucky, he, as a Republican, would have been hard to get elected because let's say he had a ceiling cap for what he could spend by the taxpayers paying for his campaign. The unions and the news would still support the majority party or the Democrats. The same could be true for Hawai'i. Now, the benefit of this bill is that it could be public financing the governor's race \$3 million, and that would definitely help Duke Aiona in his race. But at the same time, why should taxpayers be paying for campaign signs, campaign commercials, and things like that? So, I'll be voting no."
