### TENTH DAY

### Thursday, February 1, 2024

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 12:02 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Jeanne Kapela, after which the Roll was called showing all members present with the exception of Representatives Alcos and Kitagawa, who were excused.

On motion by Representative Morikawa, seconded by Representative Garcia and carried, reading of the Journal was dispensed with and the Journals of the First, Second, and Third Days were approved. (Representatives Alcos, Ichiyama, Kitagawa, and Nishimoto were excused.)

Representative Garcia rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1673, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WORKERS' COMPENSATION," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Garcia voting aye with reservations, and with Representatives Alcos and Kitagawa being excused.
