Friday, February 2, 2024

"No. Thank you. This bill designates November 22 of each year as Kimchi Day in the state. This sounds like a great idea, a lot of benefits to kimchi. But with housing being a problem, homelessness, things like that, this seems like kind of a low bar priority. So, I don't think we should be prioritizing this, so I'm voting no."

Representative Garcia rose and asked that the Clerk record an no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1950, entitled: "A BILL FOR AN ACT RELATING TO KIMCHI DAY," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Garcia and Pierick voting no, and with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Tam, for the Committee on Culture, Arts, & International Affairs, presented a report (Stand. Com. Rep. No. 16-24) recommending that H.B. No. 1899 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Tam rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Your committee on Culture, Arts, & International Affairs has heard the concerns that have been raised by the community in regards to this bill. And we have amended this bill to keep Good Friday and create World Peace Day as an observed day. This comes at no cost to the taxpayers. Thank you."

Representative Kapela rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. And I'd like to have the words of the Culture, Arts, & International Affairs Chair inserted into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Souza rose in support of the measure and asked that the remarks of Representative Tam be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1780, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WORLD PEACE DAY," passed Second Reading and was referred to the Committee on Finance, with Representatives Amato and Matsumoto voting aye with reservations, with Representative Garcia voting no, and with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Tam, for the Committee on Culture, Arts, & International Affairs, presented a report (Stand. Com. Rep. No. 18-24) recommending that H.B. No. 1555, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

No. 1555, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATE HOLIDAYS," passed Second Reading and was referred to the Committee on Finance, with Representative Garcia voting no, and with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Belatti, for the Committee on Health & Homelessness, presented a report (Stand. Com. Rep. No. 19-24) recommending that H.B. No. 2553, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

Representative Nakamura moved that the report of the Committee be adopted, and that H.B. No. 2553, HD 1 pass Second Reading and be referred to the Committee on Consumer Protection & Commerce, seconded by Representative Morikawa.

Representative Pierick rose to speak in opposition to the measure, stating:

"No. This bill authorizes pharmacists to administer vaccines to persons three years of age or older. Parental consent isn't mentioned in the bill, therefore I vote no."

Representative Garcia rose and asked that the Clerk record an no vote for him, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. Looks like a slippery slope, another kind of turf war that may be created. So, with reservations for the present time. Thank you."

Representative Marten rose to speak in support of the measure, stating:

"In strong support. This has nothing to do with parental consent. This is just allowing another convenient, trained healthcare provider to provide vaccines. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2553, HD 1, entitled: "A BILL FOR

AN ACT RELATING TO PHARMACISTS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Ward voting aye with reservations, with Representatives Garcia and Pierick voting no, and with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Evslin, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 20-24) recommending that H.B. No. 2214, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

On motion by Representative Nakamura, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2214, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOUSING," passed Second Reading and was referred to the Committee on Water & Land, with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Evslin, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 21-24) recommending that H.B. No. 2548, as amended in HD 1, pass Second Reading and be referred to the Committee on Economic Development.

Representative Nakamura moved that the report of the Committee be adopted, and that H.B. No. 2548, HD 1 pass Second Reading and be referred to the Committee on Economic Development, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure, stating:

"I'm in support, sir. This is the time when the majority reminds the minority, hey, this is second reading, you don't have to speak on this bill. Well, this is also the time that the minority says to the majority, hey, this is when the good, bad, and the ugly are pointed out. And this is one of the good ones.

"This is a good bill. It says, using what we have as a land resource on existing properties with infrastructure, we can build ADUs by giving the loan. The only difficulty I have, and my reservation would be, given that it's a loan and it's at market rates, do you know what the market rate is now, Mr. Speaker, 6%, 7% percent? \$300,000 loan, of which this is the cap, you're barely going to make your rent to pay your loan off. That is not an incentive.

"I understand there's another bill from a guy from Hawaii Kai, that says, we will match you \$1 for your \$1. And ADUs only cost \$100,000, generally speaking, where they can actually rent it out and incentivize themselves to get their money back. Because right now, from a business point of view, from an economic point of view, from an entrepreneurial point of view, the structure of the incentives just don't say I'm going to run and build an ADU. But the ADU is really the secret, one of the silver bullets to solving the housing crisis. And I know for Maui in particular, there's a bill that says for every dollar a Maui person puts in, the government will put in \$3, so we can get Maui back up and running. Otherwise, this is a good bill, it just needs to go a little bit further. Thank you, Mr. Speaker. I congratulate the author."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2548, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ACCESSORY DWELLING UNITS," passed Second Reading and was referred to the Committee on Economic Development, with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Evslin, for the Committee on Housing, presented a report (Stand. Com. Rep. No. 22-24) recommending that H.B. No. 2218, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Nakamura, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2218, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAIIAN HOMES COMMISSION ACT," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Alcos, Gates, Kila, and Nakashima being excused.

Representative Matayoshi, for the Committee on Labor & Government Operations, presented a report (Stand. Com. Rep. No. 24-24) recommending that H.B. No. 1637, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Nakamura, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1637, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WORKERS' COMPENSATION LAW," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Alcos, Gates, Kila, and Nakashima being excused.
