TWENTIETH DAY

Thursday, February 15, 2024

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 12:02 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Scott Y. Nishimoto, after which the Roll was called showing all members present with the exception of Representatives Matayoshi, Perruso, and Takayama, who were excused.

On motion by Representative Morikawa, seconded by Representative Garcia and carried, reading of the Journal was dispensed with and the Journals of the Twelfth and Thirteenth Days were approved. (Representatives Matayoshi, Perruso, and Takayama were excused.)

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS
(FLOOR PRESENTATIONS)

The following resolution (H.R. No. 11) was announced by the Clerk and the following action taken:

Representative Sayama recognized the many achievements and dedication of Dr. Sen, shared how he has promoted peacefulness through a bowl of tea through *chado* around the world, earning honors such as the UNESCO goodwill ambassador, and celebrated his upcoming 101st birthday.

Mr. Speaker, this is exactly pushing us in the opposite direction, it's saying, hey, we can actually feed people some of the food that is processed for nonprofits, which comes hopefully from axis deer and all the other places that we can have an excess, including chickens, not cats, but chickens. We've got all this excess protein we're not using. This bill opens the door for that. I commend the authors of that. And I hope this sails through and it feeds a lot of people with good protein. Thank you, Mr. Speaker."
