### TWENTY-EIGHTH DAY

### Friday, March 8, 2024

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 12:04 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Richard H.K. Onishi, after which the Roll was called showing all members present with the exception of Representatives Amato, Cochran, Gates, Ichiyama, M. Mizuno, Perruso, and Todd, who were excused.
