Wednesday, March 27, 2024

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 12:02 p.m., with Vice Speaker Ilagan presiding.

The Roll was called showing all members present with the exception of Representatives Ganaden, Kapela, La Chica, Nakashima, Nishimoto, Sayama, and Tam, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Ninth Day was deferred.
