## FIFTY-EIGHTH DAY

Friday, April 25, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 6:57 p.m., with Vice Speaker Ichiyama presiding.

## UNFINISHED BUSINESS

**Conf. Com. Rep. No. 1 and S.B. No. 1296, SD 2, HD 2, CD 1:**

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 1296, SD 2, HD 2, CD 1 pass Final Reading, seconded by Representative Morikawa.

Representative Poepe rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Poepe's written remarks are as follows:

"I want to start by saying I appreciate the work done in conference to narrow this measure and make it more clearly focused on Lahaina as it was originally intended. I'm especially grateful that a sunset date was added, and that language was brought back in to make sure structures on shoreline parcels or parcels impacted by waves, storm surges, high tides, or erosion won't qualify for this exemption.

"My concern is that this measure may set a precedent that in the wake of future disasters across the state, SMA permitting requirements may be waived without regard for the nature of the disaster, whether it's a hurricane, tsunami, flood, earthquake, volcanic eruption, or fire and without regard for the unique conditions of the disaster. A special management area is designated as 'special' for a reason. It's an area identified as having higher risks and hazards to the people and communities that live and develop there. Therefore, these areas require more careful scrutiny and examination when reviewing permitting applications, with the goal being to reduce and minimize these risks, to mitigate environmental issues and concerns, and ultimately, to create a safer outcome for all involved.

"The special management permit process also provides more scrutiny for environmental considerations and additional opportunities for community feedback. This is important not only in terms of the laws meant to protect our environment but also in terms of protecting the people who call these areas home from the hazards that qualified these areas to be placed in the special management area in the first place. I do think that the sunset date helps to alleviate this concern, it shows this isn't meant to be a long-term or permanent change. But I'd be cautious about any effort in the future to extend or remove the sunset or broaden the application of this measure. "

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."
