Thursday, January 23, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Richard DuFresne of the Central Union Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Sixth Day.

MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 18 to 27) were read by the Clerk and were disposed of as follows:
