

TENTH DAY

Tuesday, January 28, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the Vice-President in the Chair.

The Divine Blessing was invoked by Reverend Howard Corry of the Hawaii Council of Churches, after which the Roll was called showing all Senators present, with the exception of Senator Ushijima, who was excused.

The Vice-President announced that the President had read and approved the Journal of the Ninth Day.

MESSAGES FROM THE GOVERNOR
