Wednesday, January 29, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the Vice-President in the Chair.

- Senator Yamasaki, for the Committee on Legislative Management, presented a report (Stand. Com. Rep. No. 8), informing the Senate that Senate Concurrent Resolution Nos. 32 to 36, Senate Resolution Nos. 139 to 141, and Senate Bills Nos. 310 to 392 have been printed and are ready for distribution.

At this time, Senator Anderson rose and spoke as follows:

"I'd like to state for the record that we have made a request some two days ago to the Chairman of Ways and Means that there is a companion bill that will be forthcoming in the next several days; and there is a policy or a direction, question or approach in that bill that affects this one most directly. We ask that we receive that determination by the Policy Committee of the Majority Party before we vote on this tomorrow. That request still stands."

Senator R. Wong commented as follows:

"Mr. President, I think the honorable colleague across the hall is referring to a bill that in my understanding is still in committee--the Finance Committee of the House. As far as the determination being made is concerned, we have explained the situation to the Minority. And as far as a direction, I think it's incumbent upon him to get together with the Leadership to determine what the status will be relative to this bill."

The Vice-President then asked Senator Anderson whether he was satisfied with the answer.

Senator Anderson replied as follows:

"Yes, if the Majority Leadership is ready to sit and meet. We had an open invitation to hear from them. While the bill across the hall is a separate vehicle, monies appropriated in this bill relate directly to it. We would like to see the companion bill, or at least get the Majority Party's policies or approach on the second bill, before we vote on this one. So, we'll stand waiting for the Majority Leader to call us some time today."

At this time, Senator Ching rose and commented as follows:

"I know of no request to meet with the Majority Leadership, and I am perfectly satisfied with the explanation as given by the Chairman of the Ways and Means Committee."

The motion was put by the Chair and carried, and the report of the Committee was adopted, and H.B. No. 3, H.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE LEGISLATIVE AUDITOR, THE LEGISLATIVE REFERENCE

BUREAU, AND THE OMBUDSMAN", passed Second Reading and was placed on the calendar for Third Reading on Thursday, January 30, 1975.
