## Friday, January 31, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Gerald Sakamoto of the Honpa Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senators Anderson, Nishimura, Saiki, F. Wong and Young who were excused.
