#### SEVENTEENTH DAY

Thursday, February 6, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Niles Kageyama of the Windward Missionary Church, after which the Roll was called showing all Senators present with the exception of Senator Nishimura, who was excused.

The President announced that he had read and approved the Journal of the Sixteenth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Taira introduced thirtythree students from the Special Education Class at Kalakaua Intermediate School, accompanied by their teachers, Mr. Victor Nishihira, Mrs. Esther Ohta, Mr. Dai You Kim and Mr. Robert Yoshida.

Senator O'Connor then introduced twenty-six students from the American Field Service. These students come from various parts of the world such as, Venezuela, Italy, Turkey, Sweden and others.

Senator Chong introduced fifteen doctors from Indonesia who are in an exchange program and are presently studying at the School of Public Health at the University of Hawaii. Accompanying them was Mr. J. P. Chaine.

# SENATE CONCURRENT RESOLUTION

A concurrent resolution (S.C.R. No. 48), entitled: "SENATE CONCUR-RENT RESOLUTION REQUESTING THE COLLEGE OF EDUCATION, UNIVERSITY OF HAWAII, MANOA, TO LIMIT THE SIZE OF ITS UNDERGRAD -UATE TEACHER EDUCATION PROGRAM UNTIL THE PROBLEM OF TEACHER OVERSUPPLY HAS BEEN RESOLVED", was jointly offered by Senators Hara, Takitani, Ushijima, Henderson, Young, Ching, Toyofuku, Hulten, George, Kawasaki, Rohlfing, R. Wong, Yamasaki, Yim, F. Wong, Taira and Chong and was read by the Clerk.

By unanimous consent, S.C.R. No. 48 was referred jointly to the Committee on Higher Education and the Committee on Education.

We recall a week or so ago, a young man by the name of Allen Tsukasa Masuda passed away at the age of 31. Allen was a young dedicated teacher, an outreach counselor of the Department of Education, who devoted so much effort and time to young people who were in trouble in his particular community and school.

As he often said, 'If I can just keep one kid off the street and away from a life of crime, I will have made my mark.' Allan passed away at the age of 31 as a victim of leukemia.

Mr. President, I take great delight in having this Body adopt this resolution.

Thank you."

Senator Yamasaki, for the Committee on Legislative Management, presented a report (Stand. Com. Rep. No. 15), informing the Senate that Senate Concurrent Resolution No. 47, Senate Resolution Nos. 182 to 185, Senate Bill Nos. 549 to 611 and Standing Committee Report Nos. 16 to 18 have been printed and are ready for distribution.

On motion by Senator Yamasaki, seconded by Senator Henderson and carried, the report of the Committee was adopted.

Senator Toyofuku, for the Committee on Human Resources, presented a report (Stand. Com. Rep. No. 16), recommending that House Concurrent Resolution No. 20 be adopted.

On motion by Senator Toyofuku, seconded by Senator Young and carried, the report of the Committee was adopted and H.C.R. No. 20, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE CONGRESS OF THE UNITED STATES TO DIRECT THE UNITED STATES DEPARTMENT OF AGRICULTURE TO MAINTAIN FOOD STAMP PRICES AT THEIR PRESENT LEVEL", was adopted.

Senator F. Wong, for the Committee on Economic Development, presented a report (Stand. Com. Rep. No. 17), recommending that House Concurrent Resolution No. 29, H.D. 1, be adopted.

Senator F. Wong moved that the report of the Committee be adopted and that H.C.R. No. 29, H.D. 1 be adopted, seconded by Senator

Senator Anderson then rose to comment as follows:

"Mr. President, I rise to speak in favor of the resolution but also call to the President's attention that on the 23rd of January, recognizing the merits of the resolution and its contents, Senator Yee called a meeting with the industry and after several hours of discussing and rapping back and forth, Senator Yee introduced on the 24th of January, a concurrent resolution in this Body for consideration.

Several days later, a Senate Resolution was introduced on the same subject. Six days later, a House Member picks it up and we have before us now a House Concurrent Resolution.

I would hope that the President would talk to some of the committee chairmen in the spirit of fairness and cooperation.

On Opening Day, we agreed to support Majority legislation; we agreed to work around the clock, if necessary, to participate and better anything and use our expertise in bettering a piece of legislation, knowing full well that the majority of it is Democratic legislation. You expressed a fairness of considering all legislation regardless of who introduces it.

I would ask that we put away the somewhat petty politics because this is the second time in as many weeks that a Republican Senate Concurrent Resolution has been held up for various reasons and a House measure comes flying across the halls.

We ask that while we extend the offer to work, to participate and offer input, that you offer the same thing that when a Republican measure hits the floor or gets to committee, we would expect the same fair play, the same constructive input and an equal amount of consideration.

Thank you, Mr. President."

Senator F. Wong then responded as follows:

"Mr. President, I appreciate the comments of the distinguished colleague from the Windward District. I would not like this Body to, in any way, infer from the things that has been said, that petty politics was played in this particular matter.

I think the distinguished Senator

knows of the conversations that I have had with him. We have placed before the Economic Development committee, the hearing of both resolutions and it was at that time in which the House Concurrent Resolution came over.

I don't think that in this particular case, it was ever the intent of the Majority to by-pass the senatorial courtesy that was extended to Senator Yee in having the matter heard before the Economic Development Committee.

Thank you, Mr. President."

The motion was put by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 29, H.D. 1, entitled: "HOUSE CONCURRENT RESOLUTION RELATING TO THE CIVIL AERONAUTICS BOARD", was adopted.
