Wednesday, February 12, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend James F. Habenicht of St. John the Baptist Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Twentieth Day.

The Senate reconvened at 11:46 o'clock a.m.

"Mr. President and members of the Senate. On behalf of the Hawaiians, I would like to present a few tokens of our gratitude for the opportunity to come here and present our proposals to you. We only hope in the near future, we will again be on the ball field instead of in the political field.

We hope that our presentation in the State of Hawaii and as we travel on the mainland, will give due credit to this great State of Hawaii.

Thank you."

The President thanked the group and extended best wishes to the Hawaiians.
