Thursday, February 20, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Fred Tamayose of the McCully Higashi Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senator Toyofuku who was excused.

The President announced that he had read and approved the Journal of the Twenty-Fifth Day.

MESSAGES FROM THE GOVERNOR

The Queen and Princess were then presented with leis by Senators Yee and R. Wong, after which the President presented the Queen a certified copy of a resolution recently adopted by the Senate, and congratulated her and welcomed her and her party to the Senate.

Miss Sen then presented the President with the narcissus flower and wished the Senate a very successful year in the Year of the Hare, 1975.

It was Reverend Higuchi who recovered the body of the Senator's brother who died a hero in battle. In 1967, Senator Kuroda and Reverend Higuchi participated in a civic program in Thailand. Senator Kuroda also related that in 1975 Reverend Higuchi became District Governor of the Hawaii Lions, attaining that position with an inexpensive and low-keyed campaign. Senator Kuroda then asked Reverend Higuchi's friends in the gallery

to stand and be recognized.
