

## THIRTY-FIFTH DAY

Wednesday, March 5, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Homer S. Vanture of St. George's Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senator Rohlfing, who was excused.

The President announced that he had read and approved the Journal of the Thirty-Fourth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Yee introduced Mr. Ottis Vipperman from Washington D.C., who is a staff member of the Federal Energy Administration.

Senator Yee then introduced two groups of students as follows: thirty Seniors from St. Louis High School with their teacher, Mr. Rod Santos; and twenty-five students from the Fourth Grade at Kaahumanu Elementary School with their teacher, Mrs. Janet Nishikawa.

Senator F. Wong then introduced twenty-five students from the Fifth Grade at Punahou School, with their teacher, Mrs. Mabel Hefty.

Senator Kuroda then introduced Mr. Pale Eva from Western Samoa who became a U.S. citizen this morning and his mother, Mrs. Eva. Accompanying them was Mr. Cliff Enos who is the leader of an all-Samoan Boy Scout Troop in Waianae.

At 11:36 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:01 o'clock p.m.
