# THIRTY-SIXTH DAY

Thursday, March 6, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend James Long of the Episcopal Church in Hawaii, after which the Roll was called showing all Senators present with the exception of Senator Rohlfing who was excused.

The President announced that he had read and approved the Journal of the Thirty-Fifth Day.

At this time, the following introductions were made to the members of the Senate:
