

THIRTY-SEVENTH DAY

Friday, March 7, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the Vice-President in the Chair.

The Divine Blessing was invoked by Reverend Everett Curry of the Community Baptist Church, after which the Roll was called showing all Senators present with the exception of Senators Hulten and Ushijima who were excused.

The President announced that he had read and approved the Journal of the Thirty-Sixth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Nishimura introduced ninety students from the Fifth Grade at Aliiolani Elementary School, accompanied by their teachers, Miss May Yano, Miss Kay Ono and Mrs. Gale Hamilton and a parent, Mrs. Aquino.

Senator Yee then introduced several groups of students as follows: 60 students from the Fifth Grade at Ala Wai School, with their teachers, Mrs. Thelma Odo, Mrs. Betty Muraoka and Mrs. Caroline McKay; 28 Second Grade students from Manoa Elementary, with their teachers, Mrs. Patricia Basilio and Mrs. Fusae Kiyokawa; 25 students from the Third Grade at Manoa Elementary School, accompanied by their teacher, Mrs. Ellen Moriwaki and a parent, Mrs. Genoves; and 55 students from the Second and Third Grade at Royal Elementary, with their teachers, Mrs. Sharyl Haruguchi, Mrs. Dorothy Luke and Mrs. Amy Lee.

Senator Kuroda then introduced a group of 30 student government leaders from the Leadership Class at Campbell High School, with their teacher Mr. Jeffrey Hartlage.
