#### FORTY-SECOND DAY

Friday, March 14, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

I have gone through an apprenticeship in public service. I hope to continue learning as I assume my duties as the President of your University. I don't promise that I will not bring issues to you which will again cause you and me a great deal of difficulty, but then that is the nature of your job and mine. I seek your understanding. I seek your cooperation in the years to come.

I know how very busy you are, and for you to take the time out to honor me in this way is certainly appreciated by myself and by my wife Amy who has been with me through thick and thin, but always on my side.

Thank you very much."

At this time, Senator Yamasaki introduced 79 students from Lihikai School on Maui, together with their teachers Mrs. Sharon Yanagida, Mrs. Judie Iuchi, Mrs. Judith Matoi and Mr. Roy Nakasone. Also introduced were chaperones Mrs. Margaret Cabrinha, Mrs. Magdalene Fong, Mr. Noboru Nakao and Mr. David Pacheco.

Senator Yamasaki also introduced Mr. George Izaki of Maui.

Senator O'Connor then rose on a point of personal privilege and spoke as follows:

"Mr. President, I rise on a point of personal privilege.

Mr. President, this morning when I awoke I was surprised to hear on the radio that there had been a fist fight in this Chamber last night and that two Senators, whose names I didn't quite recognize, had been involved with each other. This story ran on several major radio stations this morning for several hours regarding two Senators fighting each other."

The President then commented and vouched for the fact that there was no fight here in the Senate Chambers.

Senator O'Connor then continued as follows:

"Mr. President, I didn't see one either. Therefore, I rise on a point of personal privilege to encourage the Press to be more explicit in their reporting to insure that they do report any fights which we have here in this Chambers. But when the fights occur somewhere else, I encourage them to be more explicit in detailing where those fights occurred.

I have also been encouraged by one of my colleagues to state that the Press was also inexplicit in setting down in their periodicals the time for a rather important meeting this past week having to do with the executive pay raises. As a result, a large group of people were 'mustered' to come to the Capitol at 1:00 o'clock on a certain day regarding that measure when the hearing in fact was at 9:00 o'clock.

This error, which was printed in one or more of our periodicals, caused great consternation for an entire morning and disrupted the early morning sleep of one of our distinguished Chairman of Committee.

Therefore, my point of personal privilege this morning, Mr. President, is to encourage the Press, both the written Press and oral Press, to be more explicit in the way they report your honorable Senate."

At this time, Senator Kawasaki commented as follows:

"Mr. President, I'm a little dubious about the reaction that the Press will have. Whenever we request that they report things accurately, they say that it is an infringement of their First Amendment rights. That's the argument they always use, and I just wanted to know whether Senator O'Connor was aware of this."

Senator O'Connor then stated:

"Mr. President, as one who thoroughly encourages the First Amendment rights of the Press, I still feel that they can be a little more accurate."
