SENATE CONCURRENT RESOLUTION

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Satoru R. Kawai of the Jodo Mission of Hawaii, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Second Day.

At this time, the following introductions were made to the members of the Senate:

MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. No. 82), informing the Senate that he had signed the following bill into law on March 14, 1975:
