

## FORTY-FIFTH DAY

Wednesday, March 19, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Charles Hasegawa of the Honpa Hongwanji Buddhist Temple, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Young introduced eighteen students from the Eighth Grade at Wheeler Intermediate School with their teacher, Mrs. Sanders.

Senator Anderson then introduced 30 fourth grade students from Keolu Elementary School, with their teachers, Mrs. Topping and Mrs. Eberhart.

## MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 83 and 84) were read by the Clerk and were disposed of as follows:

A message from the Governor (Gov. Msg. No. 83), transmitting a status report of the Hawaii Bicentennial International Marine Exposition Commission and requesting that \$250,000 of capital improvement funds be appropriated for fiscal year 1975-76 for planning and design work connected with the planning and the preparation of a Marine Exposition to celebrate the 200th Anniversary of the Western World Discovery of the Hawaiian Islands, was referred jointly to the Committee on Economic Development and the Committee on Ways and Means.

On motion by Senator Hara, seconded by Senator Yim and carried, S.R. No. 351 was adopted.

On motion by Senator Yamasaki, seconded by Senator Henderson and carried, the report of the Committee was adopted.

Senator Hara, for the Committee on Education, presented a report (Stand. Com. Rep. No. 661), recommending that Senate Resolution No. 264 be referred to the Committee on Ways and Means.

On motion by Senator Hara, seconded by Senator Yim and carried, the report of the Committee was adopted and S.R. No. 264, entitled: "SENATE RESOLUTION REQUESTING FORMULATION OF PROGRAM FOR SCHOOL EXCURSIONS TO OTHER ISLANDS", was referred to the Committee on Ways and Means.

Senator King, for the Committee on Ecology, Environment and Recreation, presented a report (Stand. Com. Rep. No. 662), recommending that Senate Bill No. 47 pass First Reading and be recommitted to the Committee on Ecology, Environment and Recreation.

On motion by Senator King, seconded by Senator Hulten and carried, the report of the Committee was adopted and S.B. No. 47, entitled: "A BILL FOR AN ACT RELATING TO POPULATION CONTROL", passed First Reading and was recommitted to the Committee on Ecology, Environment and Recreation.

Senator King, for the Committee on Ecology, Environment and Recreation, presented a report (Stand. Com. Rep. No. 663), recommending that Senate Bill No. 50 pass First Reading and be recommitted to the Committee on Ecology, Environment and Recreation.

On motion by Senator King, seconded

by Senator Hulten and carried, the report of the Committee was adopted and S.B. No. 50, entitled: "A BILL FOR AN ACT RELATING TO STATE BUILDINGS", passed First Reading and was recommitted to the Committee on Ecology, Environment and Recreation.

## MISCELLANEOUS COMMUNICATION

A communication from the Legislative Assembly of the State of North Dakota, (Misc. Com. No. 7), transmitting a concurrent resolution adopted by that Body calling for an amendment to the U.S. Constitution to require a balanced budget for each session of Congress except in time of war or national emergency, was read by the Clerk and was placed on file.

Senator King then rose on a point of personal privilege and spoke as follows:

"Mr. President, I rise on a point of personal privilege. We have just received the latest newsletter from the President of Hawaii Visitors Bureau and I note that the lead story has an item saying that they're going

to run these items stressing the theme in big letters 'Aloha Means Good-Buy.'

I feel a real sense of repugnance at the idea of our very special word 'aloha' being tied to dollars in this fashion.

They say that this advertisement will be a big 9-1/4" x 11-1/2" and will be running in various publications.

Although it's a very clever pun, and I like puns myself, it seems to me that they will do long-range permanent damage to the feeling people have about the word 'aloha' when they say 'Aloha Means Good-Buy.'

I'd like to take this public forum as an opportunity to urge them to reconsider running this type of ad.
